My thank you also to the many other Lodges and Districts that held events in celebration of this historic occasion. Our Founders and the early members of our Society would be so proud of our accomplishments over the years. Although somewhat modified over the course of our 125 year history, the "Plan" of our forefathers has stood the test of time as our current Mission Statement of "Protecting Families, Promoting Faith and Fraternalism, Strengthening Communities" is most relevant throughout the course of our history as a Fraternal Benefit Society.

In 2017, the GCU launched its new image and brand with a more contemporary look and feel that all generations can relate to. We recently received certificates from the United States Patent and Trademark Office approving and registering the "GCU" and "GCU Logo" as official trademarks of our Society.

The GCU has been blessed as well in terms of our financial performance. We continue to experience sound asset and surplus growth while generating excellent profitability. Assets through September 30, 2017 total \$1.675 billion, reflecting an 8.1% growth from year end 2016. Surplus through the third guarter of 2017 has grown 14.8% from year end 2016 and totals \$ 124.6 million. Despite realized write downs taken on positons within our investment portfolio, the GCU is experiencing excellent profitability thus far in 2017 of \$ 17 million. The detailed GCU third quarter financial results are presented by our Chief Financial Officer Tim Demetres along with his commentary, on page 4, which I invite you to review. We sincerely thank our members and our agents for your continued support of the GCU which is the major factor in our continued success.

The GCU experienced a very successful fraternal year as well. The various articles published in our bi-monthly GCU Magazine publication are a testimony to the commitment of the GCU at a national level and of our lodge and district members on a local level in support of our fraternal mission in providing financial and volunteer support to our churches, our communities and to individuals in need. It is the goal of vour Board of Directors to have more of our over 50,000 members participate in the fraternal programing of the GCU not only through our current lodge and district structure but through other avenues such as our newest program, GCU GO-GIVE!

The Board of Directors approved at their fourth quarter meeting additional and revamped fraternal programs for 2018 that included a new Disaster Relief Program, Lodge Compliance Rewards Program, Student Debt Relief Program, Matching Funds for non-Byzantine Christian parishes and new guidelines for our Fraternalist of the Year award. Each of these programs will be introduced over the coming months.

I have scheduled additional meetings with many of our Districts to once again review the Regional Lodge Concept that would combine our current lodges

together. We will be finalizing plans for the lodges of the former District 1 (Pittsburgh) to transform the seven current lodges into four regional lodges.

The entire GCU world extends its sympathy and condolences to the family of Nicholas Yachanicz who recently passed and served as a member of the Board of Directors for 24 years. Additional information on Mr. Yackanicz and his GCU career is located on page 44, Eternal Memory!

As we wind down another year of operations, we had an extremely productive year as many of our business plan objectives, within each of our departmental operations, were addressed with many of our goals accomplished. We are in the process of finalizing our 2018 Business Plan and Budget, continuing to address our inherent risk within our business and develop a long-term sound and succinct strategy for our Society to assure our continued success.

We are certainly keeping a close watch on interest rates that plays a most important role in our overall financial stability as well. We again want to assure our members that the GCU will continue to remain relevant and competitive within the fixed annuity and life insurance marketplace.

In closing, once again I would like to extend to all of our members and our Board of Directors my sincere appreciation for the support you have given to me as I complete another year as your President and Chief Executive Officer. Please be assured that your Board of Directors, executive officers, general counsel and management staff will continue to lead and guide our Society to ongoing success, now and into the future. A special thank you as well to our executive team, department managers,

our support staff and our sales agents for your dedicated and conscientious efforts this past year that have made a major contribution to our financial and fraternal success once again in 2017!

GCU Presents Annual Byzantine Seminary Educational Grant

I will combine some of the author's thoughts with mine to wish you all the best for the holidays!

The season sparkles with you. We open our homes to family and friends, greeting each other at wreath-decked doors under twinkling lights with the seasonal greeting, "Christ is Born!" and "Merry Christmas!"

Amid the joy of the season, a small moment often catches in our throat. We set one less place at the dinner table and cross a few names off this year's Christmas card list. At those tables and among those lists are holes left by those who aren't there. Relatives who have died. Loved ones lost to addiction. Babies who never got to be held. Families divided by divorce. A family member deployed. Children who have moved across the state, the country or the globe.

Holidays often set this truth in stark relief: Our families - and our lives - don't always look the way we expected or planned. Still, human nature is quick to judge what we see on the surface - quick to idealize others' lives - but

laughter and tears often cover up the sadness, tears and loneliness that many feel especially at Christmas. I look at my family and miss familiar faces that are replaced by newborn babies seen for the first time, and others not seen since the last holiday.

Still, here's a truth worth celebrating in a season of wonder. We keep going! Suffering and grief are met by an even stronger force: that God made human hearts resilient. We do not have to despair when our reality does not match our hopes or others' expectations. We can still embrace the good work of living out our calling.

2017 Third Quarter Financial Results

GCU is committed to serving its members and certificate holders. It is my pleasure to present the 2017 nine month results of GCU's financial achievements.

Our financial strength continues to grow and surplus reached a new high at \$124.6 million at September 30, 2017. Income before realized gains (loss) increased \$1.2 million to \$19.8 million. Net Income decreased \$1.2 million to \$17.0 million compared to \$18.2 million in 2016 due to impairing certain energy related securities that may not be fully recoverable at maturity.

Assets totaled \$1.675 billion, an increase of \$125.1 million or 8% from year end 2016 that totaled \$1.550 billion. This increase can be attributed to continued positive cash flow from strong life and annuity sales, growth in investment earnings, and expense management. Our investment portfolio, consisting primarily of investment grade corporate bonds, increased \$124 million from \$1.527 at year end 2016 to \$1.651 billion at September 30, 2017.

Total Liabilities increased \$109 million to \$1.550 billion from \$1.441 billion as of December 31, 2016. This increase is due primarily to higher life and annuity reserves of \$107 million from sales; \$0.6 million increase in the Asset Valuation Reserve, and \$3.1 million Interest Maintenance Reserve increase from deferring realized capital gains on bond sales; reduced by a \$1.5 million decrease in payable for securities purchased not yet settled.

Total Income for the nine months ended September 30, 2017 period increased \$3.9 million or 1.5% to \$262.7 million com-



pared to \$258.9 million in 2016. The increase is primarily due to continued growth in investment income of \$5.3 million and \$1.1 million increase commission allowances from ceded reinsurance reduced by \$2.6 million in overall life and annuity sales.

Operating expenses before the increase in reserves increased \$24.9 million or 22.4% for the nine months of 2017 and totaled \$136.5 million compared to \$111.6 million in 2016. The increase is primarily due to higher annuity benefits paid of \$18.1 million, exchanges to other annuity products of \$5.1 million, and higher producer commissions of \$2.3 million. We continue to control the growth in general insurance expenses which were \$4.9 million in 2017, \$0.4 million less than 2016 expenses of \$5.3 million.

The increase in life and annuity reserves decreased by \$22.2 million for the nine months to \$106.5 million compared to \$128.7 million in 2016. Reserves are established on new premiums and the emergence of claims.

Financial strength and stability is a foundational pillar of GCU. Surplus now stands at \$124.6 million compared to \$108.5 million at year-end 2016. The \$16.1 million increase in surplus is primarily attributable to net income of \$17.0 million reduced by a \$1.1 million change in unrealized loss in the net equity of subsidiary.

Total surplus is the amount we set aside for unexpected losses from operations and financial protection against business volatility. The solvency ratio at September 30, 2017 is 108.0%. The solvency ratio adjusted for the Asset Valuation Reserve (AVR) is 109.3%. These ratios reflect a strong and stable balance sheet.

The chill in the autumn breeze brings the joyous Christmas season to our doorstep. Happy holidays and Merry Christmas!

This year, the GCU Board of Directors has revitalized the GCU Foundation. The first charitable event that was set up through the Foundation was the Hurricane Relief Fund. With very little advertising it has shown to be a very successful fundraiser. The donation made to the American Red Cross and Salvation Army Hurricane Relief efforts, with donations and GCU Matching Funds was over \$11,000.

At their November 2017 meeting the GCU Board of Directors gave approval to the guidelines for immediate use of the GCU Foundation for Disaster Relief Matching Funds in the future. The Board has given the GCU President/CEO the ability to institute an emergency Matching Funds event within the first 24-48 hours of a disaster. This will allow for quicker response from the GCU membership and for maximum Matching Funds benefits to the victims.


GoGive Benefits PTSA Organization

Pierogies, Bones, and Vampires: Part 2

As we stepped off the bus in Drawsko, Poland there was not much to look at. From our parking spot outside the town's convenience store we could see the entire perimeter of the town and the miles of farmland surrounding it. There was the convenience store, a bakery, two schools, a bar, a hardware store, and a couple dozen small houses with colorful exteriors, surrounded by beautiful flower gardens. We soon learned we would be sleeping on air mattresses in the classrooms of the elementary school and saw the rest of the field school. Our "lab," was a long table in the school across the street from where we were staying, and the site was in the middle of a farmer's field about a mile away.

After the first day, we quickly settled into a routine: wake up at 6:30 AM, dig until 3 PM, first dinner at 4 PM, osteology lecture, second dinner at 7 PM, chores, study, sleep. After a couple of days, my air mattress began to feel like a Tempur-Pedic and I was asleep before my head even hit the small travel-sized pillow we were given. About 90% of the time I had no idea what I was eating, but it was delicious after spending the day out in the sun digging or hunched over a skeleton. In addition to digging in the



field, we also had an osteology course that covered all the identifiable features on all of the bones of the body and how to age and sex skeletons. Some nights we would all take our studying to the bar a block away from the school. We must have looked ridiculous to the locals with our manuals and notebooks sprawled across the table, a pen in one hand and a beer in the other.

On the weekends, we broke off into groups and headed to the train station in the next town over, Krzyz, and went to as many places as we could. The first weekend I went back to Poznan, this time seeing much more than just the airport and hotel lobby. We explored the old churches, ate ice cream that was coated in cornflakes and fried, and went to the Croissant museum where we learned how to make St. Martin's croissants and became certified croissant masters. The following weekend we travelled 6 hours

to Gdansk, where we wandered through the largest brick castle in the world, experienced the first night of a three-week long festival called St. Dominic's fair, and dipped our toes in the Baltic Sea. For our third, and final, weekend in Poland we stayed together as a school. We went to a Viking festival in northern Poland and went kayaking down the same river Pope John Paul II would visit for his vacations. By the end of my trip I had fallen in love with Poland but was ready to come home. It was time to pack up the skeletons, get my bags, and take some pierogies for the road.

I didn't find any vampires in Drawsko, but I learned that you never know where one flyer, stapled to an old bulletin board, can take you.


The group of almost one hundred



Remembrances



Nicholas Yackanicz GCU Honorary Officer

Nicholas J. Yackanicz, 87, of Whitehall, PA, a retired GCU national and honorary officer, died on November 7, 2017. He was first elected to the GCU Supreme Tribunal at the National Convention in 1968 and four years later he joined the ranks of the Board of Directors. Nick represented what was eventually to become the paradigm for new members elected to the Board, namely, young, college educated and well informed of current lifestyle and business operations.

For seven consecutive National Conventions he easily gained reelection to the Board where he served for 28 years as a member of numerous committees as called upon. In 1976, 1980 and 1984 he performed the duties of Secretary at the National Conventions. When he retired as a member of the Board at the 2000 National Convention, Nick delivered his parting message in a unique manner.

Called upon at the concluding Convention session for a few words of farewell, Nick presented his message in song. In full baritone resonance he sang, "So Long, It's Been Good to Know You" as his departing comments to the GCU Convention delegates. In recognition of his 28 years of continuous service as a national officer, the 2000 Convention delegates designated him GCU Honorary Officer, a distinction for life.

Born in Hazleton, PA, he grew up in nearby Beaver Meadows as the son of the late Nicholas and Ann (Super) Yackanicz. He graduated in 1948 from Hazleton High School, and served in the US Army during the Korean War. He then earned a bachelor's degree in commerce & finance from Bucknell University. While at Bucknell, he played on the undefeated 1951 football team, an achievement he took great pride in and one that he often related to friends and associates.

Nick worked as an accountant for Trojan Powder Co and then for PPL Electric Utilities before retiring in 1991. He was a member of St. Michael the Archangel Byzantine Catholic Church, Allentown, PA, where he served as a cantor and was a member of the Holy Name Society. He served as a youth football coach for the Fullerton AA for many years. An avid bowler, fisherman and gardener, he loved music, singing and sports, especially the New York Yankees.

Surviving are his wife of 64 years Gabriella P. (Klocek) Yackanicz; children Susan (Paul) Stafura of West Mifflin, PA, Mary (Kai) Karch of Easton, PA, Nicholas (Lori) Yackanicz Jr. of Emmaus, PA, James (Sandra) Yackanicz of Bethlehem, PA., Joseph (Jennifer) Yackanicz of Ambler, PA, Michael (Lisa) Yackanicz of South Carolina, and John (Linda) Yackanicz of Schwenksville, PA; 21 grandchildren; 10 great-grandchildren; sister Maryann Peters; and brothers Carl Yackanicz and Greg Yackanicz. He was predeceased by his granddaughter Leann and brother Paul.

The Office of Christian Burial with Divine Liturgy was celebrated in St. Michael Byzantine Catholic Church in Allentown. Burial was in the parish cemetery. Eternal memory and blessed repose.

He will long be remembered for his selfless dedication to his family, his church, his charities, and his civic and professional organizations. John's dedication to family and friends was summed up best by Drew Pavlica, a long-time friend and Garfield City Clerk. The following quote by Mr. Pavlica appeared in a tribute article in the Suburban News publication written by Kristie Cattafi. "Once you were friends with John, you had a friend for life. That's not typical in today's age. He would help anyone at the drop of a hat."
