Lessons in the Law

Protecting Your Adult Child

ou've made it. Your child has graduated from high school and is on his way to college. But while you may still view your son (or daughter) as your "kid," the law doesn't see it that way.

When a child turns 18, the law recognizes him or her as an adult, no matter what. That means if your daughter is away at college and gets into a car accident, the hospital won't give you information about her condition because you don't have the legal right to it.

To illustrate, here is a story of a family whose son was skiing in Colorado and had an accident. Frantic, the parents tried to get information from the hospital about him and could learn nothing because he was 18. The father had to hop on a plane in the middle of the night to find out if he was alive, dead or injured. The good news was his injuries were mild.

To help parents avoid this scenario, each child over 18 years of age needs a durable power of attorney for both medical and financial, as well as a living will. Last will and

testaments may also be needed.

Without these documents, you as the parent have no right to make medical or end-of-life decisions for your child.

Sometimes the issues parents need to deal with are benign but still important.

My son's car insurance needed to be straightened out while he was in college, but the insurance company wouldn't talk to me without a financial power of attorney. Fortunately, I had it.

CFO REPORT

First Quarter 2019 Financials

GCU's sustained financial strength and community focus fortifies our long-term commitment to improving the lives of our members. It is my pleasure to report our first quarter financial achievements. Highlights of the first quarter ended March 31, 2019 are as follows:

Our financial strength continues to grow at a measured pace. In addition, GCU maintained a Kroll Bond Rating Agency rating of BBB+. Total income in the first quarter was \$88 million representing an increase of \$7.4 million or 9.2% compared to the first quarter of 2018 primarily from increased annuity sales and growth in investment income. We also saw an increase in life sales following the adoption of the 2017 CSO mortality tables which had the positive effect of offering better premium rates to prospective members. Net Income for the first quarter of 2019 was \$5.8 million, slightly less than the \$6.1 million reported in 2018. Surplus increased by \$5.2 million to \$159.5 million compared to \$154.3 million at year-end 2018.

Assets grew to \$1.931 billion, an increase of \$40.4 million or 2.1% from year end 2018 that totaled \$1.891 billion. The increase is attributed to continued positive net cash flow from life and annuity operations and reinvestment of investment income.

Liabilities grew by \$35 million to \$1.772 billion at March 31, 2019 compared to \$1.737 billion as of December 31, 2018. The increase is due primarily to higher annuity reserves of \$37.9 million from net new annuity deposits offset by a de-

crease of \$2.9 million for securities purchased not yet settled.

Operating expenses, before the change in reserves, increased \$2.6 million or 6.3% for the first three months of 2019 and totaled \$43.5 million compared to \$40.9 million in 2018. The increase is primarily due to higher annuity benefits paid of \$3.7 million reduced by \$1.2 million in lower pension plan payouts. We are investing in new technology that will greatly improve our policy administration systems, member and agent portals, and make it easier for all stakeholders to do business with GCU. This multi-year project will phase in through year 2022.

The Increase in Reserves for the three months totaled \$38.7 million compared to \$33.1 million in 2018. Reserve changes are a function of premium deposits, payment of death and annuity benefits, and interest accumulation.

Financial strength and stability is a foundational pillar of GCU. We continue to ensure GCU is well positioned to meet the obligations of today and those well into the future. Surplus now stands at \$159.5 million compared to 2018 year-end surplus of \$154.3 million. The \$5.2 million increase in surplus is primarily attributable to net income of \$5.8 million reduced by a \$0.6 million increase in the Asset Valuation Reserve.

Total surplus is the amount we set aside for unexpected operating losses and affords financial protection against business volatility. Total Adjusted Capital is \$179.5 million as of March 31, 2019 and includes Surplus of \$159.5 million, the Asset Valuation Reserve of \$19.9 million, and one-half the div-

idend liability of \$150,000. This is an increase of \$5.6 million over total adjusted capital at year-end 2018. The solvency ratio based on total adjusted capital at March 31, 2019 and

December 31, 2018 are 110.2% and 110.1%, respectively. These ratios reflect a strong and stable balance sheet.

Half a Century

ifty years for some may not seem like a long time, to others it may seem like an eternity. Although many may not like change in their life, fifty years has brought about many changes in our lives and in

our Byzantine Catholic Church.

Before 1969, the Byzantine Church in America was comprised of the Archeparchy of Munhall (Pennsylvania), later changed to the Archeparchy of Pittsburgh (Pennsylvania), which consisted of part of Pennsylvania, Ohio, West Virginia and all the states in the western part of our country. A second eparchy, the Eparchy of Passaic (New Jersey), consisted of all the states that border the Atlantic Ocean.

Our church was then commonly known as the Greek Catholic Church, as was this fraternal organization known as the Greek Catholic Union. The two have been connected from the beginning with the lodges housed within established Greek Catholic churches organining to become the GCU.

In 1969 a major change occurred—a large part of the Archeparchy of Pittsburgh was divided when the Eparchy of Parma (Ohio) was established. The new eparchy consisted of most of the state of Ohio and all states west to the Pacific Ocean as well as the states south of those states. Although large in area, this new eparchy was smaller in number of churches and parishioners at the time. Since that time another eparchy was established with the cathedral and chancery first in Van Nuys (California) and presently in Phoenix (Arizona). This final act divided the then Eparchy of Parma into two separate and suffragan eparchies.

On Saturday, June 22, 2019 a 50 year celebration of the establishment of the Eparthy of Parma will be held at St. John the Baptist Cathedral in Parma, OH. The celebration of the Canonical Erectionof the Metropolitan Archeparchy will be held at the Cathedral of St. John the Baptist in Munhall, Pennsylvania on Sunday, June 23, 2019.

Pilgrimages of Thanksgiving have been planned for the Eparchy of Parma to Rome, Italy and for the Archeparchy of Pittsburgh to the Holy Land.

It is our prayer that God will continue to bless our Metropolitan Church. At many of the Divine Liturgies the Ambon Prayer prayed at the close of the Liturgy will continue to be our prayer for the Byzantine Catholic Church: "Lord, blessing those who bless you and sanctifying those who trust in you save your people and bless your inheritance. Preserve the fullness of your Church, sanctify those who love the beauty of your house, glorify them in return by your divine power, and do not forsake us who hope in you. Grant peace to your world, to your churches, to the priests, to our government and to all your people. For all generous giving and every perfect gift is from above, coming down from you, the father of lights; and we give glory, thanksgiving and worship to you, Father, Son and Holy Spirit, now and ever and forever. Amen."



2019 Scholarships

The GCU National Scholarship Committee met on Wednesday, May 8 and announced the awarding of 37 National Scholarships (36—\$1,750.⁰⁰ and 1—\$1,250.⁰⁰) together with 45 Academic Performance Scholarships in the amount of \$1,000.⁰⁰ each. Awardees appear over the next four pages.

Scholarship Committee members include: GCU National Directors Dorothy Foran-chairperson, Melanie Basl, Lisa Gulibon, Barbara Kushner and David Oleksa; Judith A. Gula of CPRL, Patricia Dietz of Lodge 151, John J. Katana of Lodge 93 and Jack Mendenhall of Lodge 10.

GCU National Scholarship recipients must maintain a minimum 2.75 GPA and submit a collage showing them volunteering within their community. Three of the awardees this year will receive an additional \$500.⁰⁰ award for maintaining a 4.0 GPA: David Gulibon of Lodge 321 in Bradenville, PA; Rebecca Harhai of SEPRL in Clairton-Munhall, PA and Alexandra Plummer of Lodge 18 in Leisenring, PA. A new requirement this year was for the applicants to create a photo collage instead of written essay focusing on "Community Service and You." The collage judged to be the best was designed by Taylor Mihalow of Lodge 93 in Northern Cambria, PA. She will receive an additional \$500.⁰⁰ award for her winning collage.

Another new addition to this year's scholarship awards was the 4.0 GPA awards for APS Scholarship recipients. Each of the awardees that has maintained a 4.0 GPA in their continuing college education received an additional award of \$250.^{oo}. 





Remembrances



John Kish GCU National Director

The GCU World lost a dedicated member and former national officer with the death of John Kish, 92 on Thursday, May 16, 2019. A very active District 5 member throughout his life time, John served nationally as a GCU Trustee from 1968 to 1972 and as a GCU National Director from 1972-1980 and then from 1984 to 2000.

Born in 1926, John was the second son and third of nine children born to the late Michael & Mary (Hresko) Kish of Wilkes-Barre Township, PA.

In World War II, he left high school early to join the U.S. Navy, serving as a Seabee in the Pacific Theater. He was on Okinawa when President Truman ordered the atomic bombing of Hiroshima and Nagasaki. Honorably discharged from the Navy, he returned home to complete his high school education, graduating with the Wilkes-Barre High School Class of 1947.

He trained to be a barber and set up shop in Ashley, PA, where he would go on to serve his customers for over 60 years.

A lifelong GCU member, John was active in numerous GCU activities. Prior to serving on the Board of Directors, John was the GCU Travel Director for many years, chronicling trips in the GCU Messenger under his column "GCU Travel Talk." His columns always had a personal touch, as seen here: "I have to describe these ham sandwiches. They were like the ones Mom used to pack in Pop's mine bucket. Each slice was threefourths of an inch thick, with one inch of baked ham. The bread was nine inches long by seven inches wide. They were delicious, but you could feed a family with them." Source: GCU Messenger, Dec. 4, 1975, GCU Travel Talk, Our Trip "Do Staroho Kraju", p. 12.

Proud of his Carpatho-Rusyn heritage, John was also active in the Carpatho-Rusyn Society (C-RS). He was a member of the C-RS Eastern PA Chapter for over 22 years and was noted for carving models of wooden churches. Examples of his work can be seen in the GCU St. Nicholas Chapel and the Heritage Institute Museum & Library in Passaic, NJ. He was also featured in the WVIA documentary on the heritage of the people of Northeastern PA.

In his later years he took up painting. Although he was not a trained iconographer, he painted images of St. Nicholas and other saints in the Byzantine style as well as non-religious paintings.

An active member of St. John the Baptist Byzantine Catholic Church in Wilkes-Barre Township, John was the chairman for the 50th & 75th Anniversary Committees celebrating the Golden and Diamond Jubilees of St. John the Baptist Byzantine Catholic Church.

His passing is a great loss to the GCU, the C-RS, the church and his family. He is survived by his children, Dr. John M. (Dolores) Kish, D.O., Terry (Dimitri) Kouris; his brother Joseph Kish, sisters Margaret Kish, Anna Mickulik, Mary (John) Kula, Helen Klos and Elizabeth Scavone; his grandchildren Nathan & Alexander Kish and John & Thanasis Kouris, his god-daughter Mary (Mark) Yagodich, and numerous nieces, nephews, great-nieces and great-nephews. Besides his parents, he was preceded in death by his wife of 58 years, Theresa and his brothers Michael & Daniel Kish.

The Divine Liturgy of Christian Burial was offered on Tuesday, May 21 by Fr. Mykhaylo Prodanets at St. John the Baptist BC Church in Wilkes-Barre Township with Mr. George Daru as cantor. Interment was private. Donations can be made in memory of John Kish to St. John the Baptist Byzantine Catholic Church, 526 Church St. Wilkes-Barre Township, PA 18702.
