Indian Summer

he lazy days of summer are well behind us! Here in Western Pennsylvania we experienced very wet weather for the most part in May and June. However, since then the following months gave us one of the longest stretches I can recall, where we can truly be thankful for a most beautiful summer! "Nature" is truly breathtaking with all the color and landscape that God has provided for us to enjoy! I do hope you and your family had an opportunity to visit the many creations of nature-my favorite is always the beach!

Well it's on to Fall and talk about colors! Although summer may be my favorite season, I do look forward to the incredible change in the landscape that occurs before our eyes as nature transitions into its "winter slumber"! In my research, an **Indian Summer** is a period of unseasonably warm, dry weather that sometimes occurs in autumn in Northern America. In an article on the

US National Weather Service's website, weather historian William R. Deedler writes that **Indian Summer** is defined as "any spell of warm, quiet, hazy weather that may occur in October or even early November" ^[1] It is usually described as occurring after a killing frost.^[1]

Late-19th century Boston lexicographer Albert Matthews made an exhaustive search of early American literature in an attempt to discover who coined the expression.^[2] The earliest reference he found dated from 1851. He also

found the phrase in a letter written in England in 1778 but discounted that as a coincidental use of the phrase.

Later research showed that the earliest known reference to Indian Summer in its current sense occurs in an essay written in the United States in the late 1770s (probably 1778) by J. Hector St. John de Crevecoeur. The letter was first published in French. The essay remained unavailable in the United States until the 1920s.^[3]

Although the exact origins of the term are uncertain,^[4] it was perhaps so-called because it was first noted in regions inhabited by Native Americans, or because the Native Americans first described it to Europeans,^[5] or it had been based on the warm and hazy conditions in autumn when Native Americans hunted.^[4]



Second Quarter 2019 Financials

CU is committed to the goodness of community and providing members with life protection and retirement benefit products. Notwithstanding the strength in the U.S. economy, we continue to see market interest rates drift to all-time lows from a slowdown in global growth and trade wars with China. Highlights of GCU's financial results for the six months ended June 30, 2019 are as follows:

Our financial strength maintains forward momentum with surplus reaching \$166.3 million, an increase of \$12.1 million from December 31, 2018. Net Income, after realized losses, was \$10.2 million in 2019 compared to \$12.4 million in 2018. In 2019, we sold certain energy related bonds at a loss of \$3.7 million to avoid further deterioration in value. In 2018, we recognized capital losses of \$1.2 million resulting in a year-over-year increase of \$2.5 million.

Assets grew to \$1.975 billion, an increase of \$84.3 million or 4.5% from \$1.891 billion at year end 2018. The increase is attributed to positive cash flows from product sales and investment earnings after covering operating costs.

Liabilities grew by \$72.2 million to \$1.808 billion at June 30, 2019 compared to \$1.736 billion as of December 31, 2018. This increase is due primarily to increased annuity reserves of \$81.7 million from net deposits and credited interest, an increase of \$1.1 million in life reserves from new sales, reduced by \$7.4 million for investment trades settled in the period and a net decrease of \$2.7 million in the asset valuation reserve.

Summary of Financial Statistics

Total Income increased \$14.8 million or 8.9% to \$181.6 million from \$166.8 million in 2018. Revenue from life and annuity premiums increased by \$11.0 million and net investment income increased \$4.6 million from the prior year.

Operating expenses, before the change in reserves, increased \$6.0 million or 7.6% for the six months of 2019 and totaled \$84.3 million compared to \$78.3 million in 2018. The increase is primarily due to higher annuity benefits paid and product exchanges of \$7.0 million reduced by \$1.3 million in lower pension plan distributions.

The Change in Reserves increased \$8.5 million for the six months and totaled \$83.3 million compared to \$74.7 million in 2018. Reserve changes are a function of premium deposits, mortality, payment of death and annuity benefits, and interest accumulation.

Financial strength and stability is a foundational pillar of GCU. Surplus now stands at \$166.3 million compared to \$154.3 million at last year-end. The increase of \$12.0 in surplus is primarily attributable to net income of \$10.2 million and an overall reduction in the Asset Valuation Reserve of \$2.6 million.

Total Surplus is the amount we set aside for unexpected losses from operations and financial protection against business volatility. Total Adjusted Capital increased \$9.4 million to \$183.1 million at June 30, 2019 compared to \$173.7 million at December 31, 2018. The solvency ratios based on total adjusted capital at June 30, 2019 and December 31, 2018 are 110.2% and 110.1%, respectively. These ratios reflect a strong and stable balance sheet.

Lessons in the Law

FREE Money?

o you want to give a gift to your church, the GCU Foundation or a charity of your choice and get a tax break too? We often say nothing is free, but with some planning there is a way to take money from an IRA or qualified annuity and not pay any taxes on the distribution.

As most people know, when you reach Age 70½, IRS rules require individuals to take annual distributions from their qualified plans—Required Minimum Distributions (RMD).

Individuals can now take a Qualified Charitable Distribution (QCD) from a traditional IRA or tax deferred annuity, free from federal taxes. The tax-free treatment of this distribution equates to a 100% deduction because an individual will not be taxed on a QCD under \$100,000.⁰⁰ annually.

IRS Publication 590 states: A qualified charitable distribution (QCD) generally is a nontaxable distribution made directly by the trustee of your IRA (other than a SEP or SIM-PLE IRA) to an organization eligible to receive tax-deduct-ible contributions. You must be at least age 70½ when the distribution Is made. Also, you must have the same type of

acknowledgment of your contribution that you would need to claim a deduction for a charitable contribution. The maximum annual exclusion for QCDs is \$100,000.⁰⁰. Any QCD in excess of the \$100,000.⁰⁰ exclusion limit is included in income as any other distribution. If you file a joint return, your spouse also can have a QCD and exclude up to \$100,000.⁰⁰. The amount of the QCD is limited to the amount of the distribution that would otherwise be included in income. If your IRA includes nondeductible contributions, the distribution is first considered to be paid out of otherwise taxable income.

The bottom line is that in most cases an individual can give a gift to their church, the GCU Foundation, or a charity of choice from an IRA or qualified annuity—FREE from taxes. There are tax laws on how you do this, so please consult a tax advisor for information before proceeding with a QCD.

If you would like to proceed with a QCD from your GCU qualified account(s), please contact the GCU Call Center at 855-306-0607 for information on your qualified accounts and to explore the possibility of taking advantage of a tax-free charitable distribution.

We are in the process of planning for all of your year end requests so that we can assure that each request is addressed in a timely and efficient manner. Please be informed that the GCU has established a cut-off date of Monday, December 16, 2019 for receiving Annuity Partial Withdrawal (including RMD & Inherited IRA distributions), Annuity Cash Surrender and Life Insurance Cash Surrender requests for processing by Thursday, December 26, 2019. This includes requests received via fax, emails, web requests & mail via courier or the US Postal Service. **Please note that a W-9 Form will need to be completed and forwarded with any requests for withdrawals or surrenders.**

If the information is received and in good order by the end of business on Monday, December 16 it will be processed by Thursday, December 26 for the 2019 tax reporting period.

If requests and all documentation are received after close of business on December 16, the GCU will work to complete the request by December 26, but cannot guarantee processing before year end.

GCU Hosts AFA Event



Miss Czech-Slovak US 2019-2020 National Queen Anna Sophia Tombazzi

Many thanks for the encouragement and trust of GCU Lodge 302 President Judy Weitzel, who at the lodge's February 2019 meeting suggested sponsoring GCU member Anna Tombazzi, in her quest to obtain the Miss Czech-Slovak US 2019-2020 crown. Anna attained her goal being crowned as the first ever Miss Czech-Slovak US of Rusyn descent.

The journey to Anna's national title began as a member of the Cleveland, OH based Rusyn folk ensemble, Karpato-Rus' Ensemble in 2009. Anna was the lead violinist and a dancer. Her

mother, Laurel Tombazzi, was the ensemble director. Laurel received information about the Miss Czech-Slovak US Pageant, but the Pageant requires ladies age 16 to 26, the Karpato-Rus' Ensemble had no female performers old enough at the time.

In 2015, Laurel notice on the Miss Czech-Slovak US Pageant website that the nationalities of Czech, Silesian, Moravian and Slovak were listed on the pageant application. The winning contestant is awarded a trip to either the Czech Republic or Slovakia. Since Rusyns live in Eastern Slovakia, Laurel asked the pageant committee to add "Rusyn" to the application. (Rusyns live as a minority group in present day Slovakia and do not have a land to call their own.) The committee happily agreed and asked Laurel to be one of three judges to select a Queen that same year.

The Czech Days Festival has been ongoing for 58 years in Wilber, NE. The event draws over 50,000 people annually during the first weekend of August with the Pageant as a part of the festivities. The single female contestants are judged in four categories: private interview, on-stage interview, Kroj (costume) modeling and talent. Despite the huge crowd, contestants only need to impress the three judges during the two day Pageant.

Anna's maternal Rusyn lineage comes from her great-grandfather, Stephen Pusti from Šoma (now called Driencia) in Šaryš County near Prešov. Her great-grandmother, Anna Bittner Pusti was from Kamienka, in Spiš County. Both of Anna's great-grandparents came to America in the early 1900's.

Born and raised in Ohio, Anna was active in her Rusyn heritage from a young age: donating to an orphanage in Eastern Slovakia, speaking on a Rusyn Radio program based out of Pittsburgh, PA and acting as a family's little girl in a traditional Christmas Eve Velija play in Youngstown, OH. Anna has also played her violin at multiple Rusyn cultural events and volunteered at other ethnic centered festival events.

A GCU scholarship awardee, Anna completed her Chemical Engineering degree from the University of Akron, OH in May 2018 with minors in mathematics, chemistry and business. Upon college graduation, Anna accepted a position at

The Spaceship Company/Virgin Galactic in Mojave, CA, as a Spaceship Propulsion Test Engineer testing the most powerful hybrid rocket motor in the world.

Anna received three individual awards at the Pageant: Oratory, Authentic Kroj and Grand Talent. Her authentic Kroj (costume) was from Ugoča County in the foothills of the Carpathian mountain range. Anna performed on her great-grandfather's violin "The Valleys of the Mountains," a Rusyn medley, as her talent.

Anna stated why she wanted to become Miss Czech-Slovak US "...As a rocket scientist with humble beginnings and Rusyn roots, I aspire to be Miss Czech-Slovak US because I want to be an ethnic face both in the scientific and to the rest of the world shattering the perceived segregation of being both strong culturally rooted and working on cutting edge technology..."

Anna belongs to a 100% GCU Lodge 302 family. She is the daughter of Frank & Laurel Tombazzi, younger sister of Joseph, granddaughter of Florence Pusti Orris, and niece to the lodge's Publicity Directory Chris Bratnick. Anna is a member of the Proto-Cathedral of St. Mary in Sherman Oaks, CA.

As Anna begins a year of travel as National Queen, she is happy to share her Rusyn knowledge and gratefulness to the GCU for sponsoring her in this historic event. Congratulations Anna!

The GCU Board of Directors realizes that many young members complete college with significant Student Debt and has approved continuation of the GCU Student Debt Program. The budget established will provide up to 100 awards in 2019. The program assists GCU members with a portion of their Student Debt. The program is open to both new applicants and to those that received the award in 2018.

Members that qualify are eligible for four annual awards of \$500.⁰⁰ each. Members are required to apply annually to receive the award. 

Very Reverend Archpriest Dennis M. Bogda Past Supreme Tribunal Member

Very Rev. Archpriest Dennis M. Bogda, former member of the GCU Supreme Tribunal, passed away on September 21. 2019 at the age of 78.

He was born in Homestead, PA on June 7, 1941, the eldest child of the late Michael & Mary Bogda. He entered SS. Cyril & Methodius Byzantine Catholic Seminary in 1959, to pursue studies for the priesthood. He received his Bachelor of Arts in Philosophy from Duquesne University in 1963 and was ordained to the priesthood on April 23, 1967. In 1978 he received a Master's Degree in Theology from Duquesne University. A second Master's Degree in Community Counseling was achieved from Youngstown University.

Archpriest Dennis Bogda served in Byzantine Catholic parishes in Euclid, OH; Brownsville, PA; Duquesne, PA; Monroeville, PA; Youngstown, OH; Lyndora, PA and as rector of St. John the Baptist Cathedral, Munhall, PA. He also served the Archeparchy as: Syncellus for Deacons; Committee of Consultors, Secretary; Presbyteral Council; Renewal and Vitalization; Vocations, Director; Vocations Committee, Chair; Vocation Interview Board and St. Cyril & Methodius Seminary, Board of Directors, Secretary. He was conferred the title of Archpriest by Metropolitan Basil Schott.

Father Dennis served as chaplain for several lodges and districts before being elected to the GCU Tribunal at the 2004 GCU National Convention and reelected at all of the following Conventions through 2016. He continued to serve on the Tribunal until it was dissolved earlier this year.

His obituary, published in the Pittsburgh Post-Gazette, truly highlighted how he lived his life, "It is with Great Thankfulness that the servant of God, the Archpriest Dennis Bogda has returned to his Heavenly Father whole and renewed. He fought and conquered multiple illnesses due to his strong spirit and desire to serve in the Priesthood of Christ. He was a wonderful witness of the suffering of Christ."

Survivors include his sister, Elaine Bogda and cousins. In addition to his parents, he was preceded in death by a sister, Mary Ann Bogda; uncles, Rev. Michael Kushner and John Bogda; and grandparents, Andrew & Anna Kushner and John & Ann Bogda.

Visitation took place at St. John the

Baptist Cathedral in Munhall on Sunday, September 29. His Funeral Liturgy was celebrated at the Cathedral on Monday, September 30 with Most Rev. Metropolitan Archbishop William C. Skurla as celebrant. Concelebrants included: Bishop Kurt Burnett, Archpriest John Petro, Archpriest Eugene Yackanich, Rev. Robert Karl, Very Rev. Ron Larko, Very Rev. Frank Firko, Rev. Kevin Marks and Deacon Paul Simko. He was laid to rest at the Cross in St. John the Baptist Byzantine Catholic Cemetery, Munhall, along with other priestly vocations from his home parish of St. John the Baptist Cathedral.

Sister Ann Fedyszak

Very early in the morning of Monday, August 12, 2019, Sister Ann Fedyszak (formerly Sister Aloysius) completed her earthly life and awoke to the dawn of her new life in the heavenly Kingdom. Sister Ann had been a resident of Mt. Macrina Manor just shy of seven years.

Sister Ann was born in Warren, OH, the daughter of the late Elias & Anna (Volchko) Fedyszak. She entered the Sisters of St. Basil in Uniontown on September 15, 1954 from SS. Peter & Paul Byzantine Catholic Church in Warren. Sister Ann made her Final Profession of Vows on August 21, 1960 in the presence of the late Very Rev. Msgr. John Gernat.

Finally, as a resident at the Manor, Sister Ann was known for ministering to others. Sister Ann wanted to be remembered for her deep faith, and it was surely this that was the hallmark of her life.

In his homily, Archbishop William noted that Sister Ann, strengthened by her spirit of prayer and meditation, lived in the hope of Resurrection. It was evident that this spirit formed her life and ministry, forming and shaping the lives of many who came into the orbit of her influence. Like Sister Ann, we are all called to become wise and faithful stewards of the gifts given to us by God, inspiring generations to come to walk in the way of the Gospel

Sister Ann was preceded in death by her parents, her sister Mary (DeSantis) and her brother John. In addition to her Sisters in community, she is survived by her brother Joseph and her sister, Sister Margaret.
