Blessings in a Troubled Year

In Western Pennsylvania, this summer has been one of the most perfect summers I can remember. At times it was very hot and humid, but for me, I enjoy this type of weather. Under the current pandemic and social distancing restrictions put in place, the weather we experienced was “just what the doctor ordered!”

Many businesses have flourished under this environment such as the sales of recreational vehicles and bicycles. The golf industry is also experiencing a spike in the sale of equipment, increased rounds played in addition to more interest by families and individuals seeking private club memberships. Membership at Seven Oaks Country Club, a private club owned by the GCU Holding Company, has experienced a 63% increase in membership thus far over 2019. If anything positive can be linked to this pandemic it is that we are getting out of the house to enjoy more of the outdoors and what nature has to offer. Over the next several weeks the summer landscape will transform itself into one of the most spectacular phenomena of nature—presenting a most colorful picturesque portrait as nature prepares for its winter slumber. I do hope you have an opportunity to enjoy “God’s Country” during this fall season!

Despite the current COVID-19 pandemic environment, it has been “business as usual” for the GCU. As the safety of our employees is first and foremost, many of our employees are continuing to work remotely as requested by the Governor of the Commonwealth of Pennsylvania, Tom Wolf. We express our gratitude to our entire Staff in continuing to provide exceptional service to our members and agents.

The pandemic has certainly negatively affected all businesses. GCU is very fortunate to tout a strong distribution force that promotes our life and annuity business and believes in our mission as a fraternal benefit society. We thank each of our agents for introducing GCU and our product lines to your clients.

Our annuity sales are 85% of goal (cash with application) with our overall total annuity premium received in 2020 at 89% of goal. In comparing total annuity premium year to date through September, we are behind 2019’s total premium by \$1.5 million or .0085% (Less than 1%).

Our life sales are 48% of goal (first year commissionable

premium) with our overall total life premium received in 2020 at 47% of goal. In comparing total life premium year to date through September, we are ahead of 2019’s total premium by \$1.4 million. The primary reason for falling short of our first-year commissionable premium goal, in addition to the pandemic challenges, is due to the delay in fully launching our newly developed final expense product. We are currently testing live with eight agents and working out all the “kinks” to achieve a flawless process for instantaneous decisions on applications submitted. The full launch of this product is scheduled for October 12th. Once launched, we will experience increased premium in the fourth quarter and into the future.

The GCU continues to experience growth in assets and surplus while continuing to experience excellent net profit before refunds and realized gains and losses. As previously reported the energy sector continues to be challenged as realized losses were recorded in our second quarter financial statement. The GCU’s second quarter financial statements are presented on page 4. Our Chief Financial Officer Tim Demetres, presents a detailed commentary on our 2020 second quarter results including the issues we are experiencing with investments within the energy sector.

We reside in the greatest country in the world. We enjoy the freedoms to live life as we please and take advantage of the various opportunities that allow us to strive to make our dreams a reality in creating the best possible lives for each of us and our families. These freedoms were the dreams of our ancestors who first arrived on the shores of America when they fled their homelands in search of independence and a better way of life. The Founding Fathers laid the foundation of our government through the Constitution of the United States and the Bill of Rights that established our country as a republic in which the supreme power is held by the people represented through elected officials. We thank all of the members that exercised their right to vote under the amended Bylaws of the GCU. We once again congratulate each of the ten incumbent Directors on their re-election. The newly elected Board of Directors is presented to you below. We welcome to the Board Rt. Reverend John Kachuba as our newly elected Spiritual Advisor. Father John is no stranger to the governance process of the GCU as he served as Chairman of the Supreme Tribunal and as Chairman of the Credential Committee for many of the GCU's Conventions. Again, welcome Father John!

Our fraternal programming for 2020 has had limited activity. We thank each of our lodges and districts that have been able to conduct events within the social distancing guidelines of the Center for Disease Control (CDC) and state and local mandates. We invite you to participate in the GCU's GoGIVE! Direct and Special COVID-19 Go-

Give! programs that can be done from the comfort of your home. Both programs were designed as Matching Fund Programs to enhance monetary charitable contributions made by individual GCU members. More information on these two programs are available on the GCU website—www.GCUusa.com.

As our western states are experiencing devastating forest fires and our southern gulf and Atlantic seaboard states are dealing with severe damage created by hurricanes, we have once again activated a special matching funds program to financially support the efforts of Catholic Charities, the American Red Cross and the Salvation Army to supply various life sustaining needs to individuals and families affected by these natural disasters. Total donations as of October 4, with a few days left to go in the drive, were over \$3,600.⁰⁰ collected by the GCU Foundation in support of this effort. This total will be matched by the GCU resulting in a total of over \$7,200.⁰⁰ equally split amongst the three organizations. We thank all that have contributed to this cause.

In closing, my continued well wishes to you and to your loved ones that you continue to remain safe during this pandemic. Please take some time to enjoy the fall season that God has created for us. Also, do your part in combating this virus by abiding by the guidelines established that will assist in limiting its spread. We must continue to pray and call upon our Lord & Savior Jesus Christ and St. Nicholas, the patron saint of the GCU, to continue to inspire and provide the wisdom to the many individuals striving to develop a vaccine to combat this deadly disease.

GCU 2020 Fraternalist of the Year



The GCU Fraternalist of the Year

award recognizes an individual member who is the embodiment of fraternalism. Someone who lives a life of service through their local lodge, church, and community.

After consideration of the candidates submitted to the committee, Dr. Sherri Ann Homanko, a clinical pharmacist at a critical illness recovery hospital and Greater Hazleton Regional Lodge (GHRL) member, was chosen the 2020 GCU Fraternalist of the Year. Sherri not only works full time at her occupation, she also cares for church parishioners that are part of her GCU lodge. She spends time after her shift or during her breaks to pay a visit and give these special patients some familiar company. Sherri was the main care giver for her father following an extensive surgery in November 2019. She still finds time to volunteer countless hours in her community—touching the lives of many.

Sherri serves as secretary of the West Hazleton Lions Club. With the Lions she participates in many activities benefiting her community including the West Hazleton Christmas Tree lighting welcoming Santa Claus and answering telephones for the American Cancer Society Telethon. As a Board member with Greater Hazleton CAN DO, Inc. representing the West Hazleton Lions Club, Sherri serves on the Community Relations Committee, serves as the Industrial Park's Curb Appeal Event co-Chair and has served on the annual dinner committee. She volunteers with the student

action subcommittee, mentoring and participating with CAN DO's Community Christmas where youth from various schools in the region perform for the community. Most recently, she has been spreading information for grants and COVID-19 relief financial options throughout businesses in the area for assistance in these troubling times.

Sherri is the Executive Director of the Miss Greater Hazleton Scholarship Organization (MGHSO) where she mentors young women ages 12-25. The program provides the benefits of community service, resume preparation, communication growth, interview skill improvement, public speaking, confidence building, talent development, networking, goal setting, fundraising skills, lifelong friendships, professional development and scholarship opportunities. MGHSO holds three annual fundraising events—Halloween Harvest Party, Christmas Character Breakfast and the Easter Bunny Brunch & Egg Hunt. At all events, a canned food drive is held to support food banks. Funds are used to support scholarships and community service initiatives.

Sherri volunteers for Hazleton's FUN-

Fest and helped organize the launch of HOMETOWN HEROES in 2019 with Mike Sosar. She also arranges for teens to dress as familiar princesses to spread happiness for children.

As a volunteer at the Hazleton UNICO's Bell Italia Festival she organizes the Kiddie Korner, featuring free games and face painting for children. She has titleholders from the Miss Greater Hazleton Scholarship Organization and cheerleaders in the Hazleton Area School District volunteer.

At Butler Township's Fall Festival, Sherri assists in organizing participation in their parade and face painting. In addition, Sherri arranges for Butler Township to have MGHSO Titleholders present at their Annual Christmas Tree Lighting ceremony.

At Hazle Township's Christmas in the Park, Sherri organizes the S'more stand for attendees to have a tasty snack while they warm up by the fire pits.

The 2019 Christmas in Conyngham was not going to be held for the first time in four years. Sherri and her friends arranged a committee and

Second Quarter 2020 Financials

GCU is committed to serving our members during these uncertain times brought on by the Coronavirus (COVID-19). We are firmly positioned to withstand the impact of the pandemic because of our dedicated employees and our financial strength. The economy is improving with unemployment levels dropping, mortgage rates are low for home buyers, and equity & bond valuations are increasing to pre COVID-19 levels. While certain industries continue to struggle, we are prudently managing our investments and will impair those securities unlikely to recover in value, particularly energy sector holdings. By doing so, we put these exposures behind us.

Highlights of the 2020 half-year results are as follows:

Income before net capital gains (losses) totaled \$13.8 million slightly under the \$14 million reported in 2019. Net realized capital losses were \$10.7 million in 2020 compared to \$3.7 million in 2019. We impaired three energy bonds that filed for bankruptcy protection due to low demand and low energy prices, a situation that was exacerbated by COVID-19. As a result, net income after net realized losses was \$3.1 million in 2020 compared to \$10.2 million in 2019. Notwithstanding the impact realized losses had on net income, surplus was largely protected by a release of the asset valuation reserve (AVR). The AVR is a liability built-up over time and used to soften the negative impact to surplus from deteriorating credit losses. Our goal is to insure GCU maintains its financial strength to meet member obligations well into the future!

Total Assets increased \$72.8 million to \$2.125 billion at June 30th from year-end 2019. The increase in assets reflects continued growth in invested assets from excess operating cash flows. We are strategically focused on asset allocation and generating risk adjusted returns to support our life and annuity products. A key component of this strategy is to complement our fixed income holdings by increasing exposure to public equities and alternative assets (investments in LLC's and limited partnerships).

Liabilities grew commensurate with life and annuity sales and totaled \$1.955 billion at June 30 compared to \$1.890 billion at year-end 2019. The \$65.5 million increase in total liabilities is due primarily to a \$72.5 million increase in life and annuity reserves off-set by a \$7.9 million decrease in AVR.

Total Income for the first half 2020 was \$181.5 million compared to \$181.6 million in 2019. Life sales have increased 33% over prior year and continued growth is expected in the second half from the introduction of GCU's final expense life insurance product.

Operating expenses, before increase in reserves, totaled \$99.4 million versus \$84.3 million in 2019 representing an increase of \$15.1 million or 17.9%. In support of our members during the pandemic, GCU paid \$11.3 million more in annuity benefits (death claims, full and partial withdrawals), as well as exchanged certain annuity contracts to new contracts totaling \$4.3 million. General insurance expenses were flat compared to 2019.

The increase in reserves totaled \$68.2 million compared to \$83.3 million in 2019. Reserve changes are primarily a function of premiums received, death and annuity benefits paid out, and interest accumulation.

Surplus grew to \$170.1 million at June 30th compared to \$162.7 million at year-end. The \$7.3 million increase in surplus is attributable to the additions of net income and

the change in AVR of \$3.1 million and \$7.9 million, respectively, off-set by decreases in unrealized gains/losses (\$1.7 million); a (\$1.3 million) charge for an increase in non-admitted assets software development costs and a (\$0.7 million) reduction for GCU Holding Company's net loss.

Total Adjusted Capital (TAC) at June 30, 2020 is \$181.0 million. TAC starts with surplus of \$170.1 million and adds back the asset valuation reserve of \$10.8 million and one-

half the dividend liability of \$150,000. TAC is used as a financial strength measure by rating agencies. The solvency ratios based on TAC at June 30, 2020 and 2019 are 109.3% and 109.7%, respectively. These ratios reflect the continued financial strength of GCU.

New Beginnings

New Beginnings can be exciting, scary, doubtful, frustrating, and visionary. To begin something new for an individual or an organization can be all of the above.

In 1892 clergy and laity from the Subcarpathian region of Europe met in Wilkes-Barre, PA to form a fraternal union, to be known as the Greek Catholic Union. This group of people wanted to ensure that its members were cared for financially, to provide the means for a good education, to aid their churches, and to promote friendship among its members. St. Nicholas of Myra was chosen as their patron and protector. In the coming years, when difficulties arose, St. Nicholas was there to protect. This new beginning was exciting, scary, and visionary – **A NEW BEGINNING.**

In 1936 eight hundred delegates of the Greek Catholic Union met in Wilkes-Barre, Pennsylvania, the place where it had been founded, at a most critical time in the life of the GCU. The Organization was experiencing a loss of members, difficulties in the Church, internal and financial problems. It was decided that the members not discuss the internal problems of the Church, and that the religious character of the organization remain the same. The decisions made at this convention and in the following years not only brought new life to the Organization but also new ideas. It could be said, I propose, St. Nicholas was there guiding the GCU after its first 50 years – **A NEW BEGINNING.**

In 1972 another significant moment in the life of the GCU took place. Numerous bylaws were changed, and the delegates unanimously endorsed a plan for the reorganization of the GCU. It was decided to consolidate all operations. The three branches of the GCU; the General Branch, the Gymnastic Branch, and the Juvenile Branch were merged into one—the main objectives of the GCU

would remain: religion, fraternalism, education and sports. The new governing board, now known as the Board of Directors, along with the Executive Officers took over the responsibility of serving its members. And, of course, St. Nicholas was watching over them – **A NEW BEGINNING.**

Other significant new beginnings occurred in 1978 when Seven Oaks Country Club was dedicated by Archbishop Stephen Kocisko; in 1987 when the GCU moved to its new Home Office in Beaver, PA; in 1988 when a resolution passed to build St. Nicholas Chapel, which was dedicated in 1992 by Archbishop Thomas Dolinay and in 1995 when Archbishop Metropolitan Judson Procyk proclaimed the St. Nicholas Chapel as an official church and public oratory. I am sure St. Nicholas blessed all who were involved in this magnificent chapel dedicated to him. The New Millennium saw the United Societies merge with the GCU in 2000 – **NEW BEGINNINGS.**

In the 128 years of existence of the GCU many more significant events have occurred. My intention was not to present a history of the GCU, but to point out that all these events were new beginnings that entailed times of excitement, fear, doubt, frustration and a continuing vision for this great organization.

My journey with the GCU began in 1984 when I attended my first convention in Philadelphia. General Counsel Sigmund Brinsky appointed me to serve on the legal committee. In 2004 I was honored to serve as the Chair of the Credentials Committee for the 39th National Convention, and for the next three Conventions. In 2016 I was honored to be elected by the members present at the Convention as the Chair of the Supreme Tribunal.

In October 2020, my service to God's people takes on another new dimension. This service began in 1974 as God gave me the gift of the Holy Priesthood. Through those years, I have served the People of God with the gifts bestowed on me by Him. I take on this responsibility as the Spiritual Director of the GCU with great appreciation. I believe that St. Nicholas, the patron of the GCU and the patron of our Byzantine Catholic Church, had a role to play in this. I want to thank all of you GCU members for your confidence in me by electing me to this position. I also want to thank Fr. Richard Lambert for his encouragement and his many years of serving as the Spiritual Director before me. When we began our seminary career together in 1966, we could have never imagined it would take us to where we are today. I spoke about new beginnings throughout this article and as I enter this new beginning in my life, I ask for your prayers that I may serve you to the best of my ability – **A NEW BEGINNING!**

Lessons in the Law

It's Not About Who You Know

Just as you wouldn't ask a urologist to perform open heart surgery, a criminal attorney shouldn't be the one that handles your will, trust, or powers of attorney. The seemingly simple step of executing a healthcare power of attorney can pose serious complications for the person who doesn't know the ins and out of Ohio law.

I recall the story of a client who was prepping for surgery and decided to get his affairs in order in advance. His wife told a criminal lawyer friend in New Jersey about what she and her husband were planning to do, and he offered to save her a little money by doing the work himself. Prior to his surgery, the man became unexpectedly ill and it was then that the family discovered that the criminal lawyer friend had used the wrong power of attorney forms. Essentially the forms he used negated everything the family wanted and they weren't valid in Ohio. It was a mess and they had to wait until the man was well enough

The GCU Board of Directors realizes that many young members complete college with significant Student Debt and has approved continuation of the GCU Student Debt Program. The budget established will provide up to 100 awards in 2020. The program assists GCU members with a portion of their Student Debt. The program is open to both new applicants and to those that received the award in 2018 and/or 2019.

Members that qualify are eligible for four annual awards of \$500.⁰⁰ each. Members are required to apply annually to receive the award. Requirements include: GCU membership as of 12/31/2019 with a permanent life insurance certificate or annuity with a current balance of at least \$2,000.⁰⁰. Proof of at least two years of payments on their student loan(s) and volunteer involvement will also be required. All applications must be completed online. Once membership requirements have been verified, the applicant will receive an email with the additional requirements. Awards are presented on a first come, first served basis, based on the date when all required information has been received and not initial application date.




District 5

St. Macrina in Uniontown, PA each received a check for \$500.00 to be used as needed.

I applaud the GCU Board of Directors and Mr. Juba, for the abundance of caution for our members as reflected in their deliberations and ultimate guidelines for the rest of the year. Clearly, these were not easy decisions; we are grateful for your leadership.

The District 15 Board offers our continued prayers for our members, and for the continued success of the GCU. We look toward 2021 with hope for an end to the pandemic and return to our regular fraternal events.

This includes requests received via fax, emails, web requests & mail via courier or the US Postal Service. **Please note that a W-9 Form will need to be completed and forwarded with any requests for withdrawals or surrenders.**

If the information is received and in good order by the end of business on Wednesday, December 16 it will be processed by Tuesday, December 29 for the 2020 tax reporting period.

If requests and all documentation are received after close of business on December 16, the GCU will work to complete the request by December 29, but cannot guarantee processing before year end.







Remembrances

Eugene P. Lucas

Eugene P. Lucas, of Munhall, PA and a GCU member, died on July 20, 2020, age 81. He was the son of the late Michael and Laura (Rulka) Lucas and a lifelong member of St. John the Baptist Byzantine Catholic Cathedral.

If one were limited in words to describe the life of Gene Lucas, it could be described as “simple” and “charitable.” A person with strong values, Gene Lucas took an uncomplicated life and translated it into one of constantly thinking of others. Of the many, many people who would meet him throughout his lifetime, most or all would attest that he was a man of integrity and great charity.

Born in Munhall, Gene lived his entire life there and received his Christian burial in that same community. After high school and serving in the United States Army, Gene moved onto employment that thousands of classmates, friends and neighbors also engaged, the steel mills. The communities of Munhall, Homestead and West Homestead in Western Pennsylvania are known as “Steel Valley,” and at that time steel was a natural transition for young graduates and veterans. It was the late 1950s and throughout the United States steel workers experienced very favorable increases in wages and benefits.

Gene Lucas never married, lived at his family home, went to work, went to church, and lived a simple lifestyle. He enjoyed college and professional sports, and his one luxury was an annual weekend trip to Florida to see a University of Pittsburgh football game.

All of this experienced a sudden jolt in the early 1980s with the closure of the steel mills. In his early 40s, Gene had worked long enough to have a pension income, and since he lived with his then widowed mother and

had no other familial responsibilities, he considered himself retired.

Along with his retirement came a major change in his lifestyle. St. John’s had just constructed its Cathedral Center, and parishioners were called upon to volunteer their services at the Center’s catering fundraising project. The Cathedral Rector at that time, Msgr. Judson Procyk, was the mastermind behind this fund raiser. People were attracted to him and cheerfully gave their time to completely staff the catering service which soon was hosting events of 500 or more.

Gene Lucas was among the one hundred or more early volunteers. At first he was involved in set up and clean up, both essentials to any successful event. Soon he moved onto beverage service, and his quiet nature and efficient workstyle made him a superb bartender. He became part of a volunteer team that prided itself in excellence.

Before long Gene would be called upon for more. He lived less than one mile from the Cathedral, had no job or family responsibilities, and could be summoned at any time. Msgr. Procyk saw fit to give a set of Cathedral Center keys to Gene Lucas and to call upon him for whatever need may arise. Gene for his part accepted the newfound responsibilities as an honor and an opportunity to further give of his talents for the good of his church and other people.

His simple lifestyle, rewarded by his annual weekend in Florida, weekly outings at a public golf course with a group of locals, and daily jaunts to Munhall’s Main Street to chat and critique the local political scenario, continued for most of the second half of his life. But not without strife. In the late 1990s he was diagnosed with serious illness, experienced months of

total disability, only to emerge anew, healthy and filled with a zest for life.

Even with his life threatened by the illness, Gene returned to life as he preferred it, simple and charitable. He resumed his volunteerism, and continued to support his church, the Byzantine Catholic Seminary in Pittsburgh, and other causes. When asked how he was doing, Gene, a person of few words, had only positive and encouraging comments. And so it would be until his final day.

He is survived by three nephews, Ronald, Jr. (Pamela), Daniel (Angela), and David (Judi) Lucas; a niece, Maureen (Arthur) Whittemore; and several cousins. In addition to his parents he was preceded in death by a brother Ronald (and wife Margaret) Lucas, and a niece Kathleen Lucas.

The Divine Liturgy of Christian Burial was celebrated at St. John the Baptist Byzantine Catholic Cathedral by Very Rev. Andrew Deskevich and Very Rev. Robert Pipta. Former Cathedral rector, Father Robert Karl was in attendance. Interment was in St. John the Baptist Cemetery, Munhall.

Eternal memory and blessed repose.
