

AM Best has assigned a Financial Strength Rating of A- (Excellent) and a Long-Term Issuer Credit Rating of "a-" (Excellent) to GCU (Beaver, PA). The outlook assigned to these Credit Ratings (ratings) is stable.

The ratings reflect GCU's balance sheet strength, which AM Best assesses as adequate, as well as its strong operating performance, neutral business profile, and appropriate enterprise risk management.

GCU, formerly known as the Greek Catholic Union of the USA, is a fraternal benefit society that provides members with retirement products, life insurance, as well as a small closed block of Medicare supplement insurance. GCU is in its 130th year of operation since its founding on Feb. 14, 1892. GCU is domiciled in Pennsylvania, and the society's products are distributed to members through contracted field marketing organizations and independent agents.

The ratings reflect GCU's positive sales and membership growth, earnings trend and diversification efforts, but are partially offset by challenges in a competitive marketplace and a heavier interest-sensitive business profile. GCU has recorded strong growth in operating earnings through management of annuity spreads. Furthermore, unassigned funds continue to increase, resulting in an adequate level of risk-adjusted capitalization, as measured by Best's Capital Adequacy Ratio (BCAR), despite an increase in investment risk in recent periods.

Partially offsetting these positive rating factors is the society's limited business profile, as approximately 38% of its direct premiums are derived from Pennsylvania and deferred fixed annuities account for almost all of the company's net premiums and reserve liabilities. Additionally, the majority of fixed annuities have a relatively high guaranteed minimum crediting rate greater than or equal to 3% per annum, and so GCU gradually increased its risk appetite within the investment portfolio in recent years to offset spread compression. Sales of single premium whole life have increased in recent years, but remain only a modest proportion of overall premiums and currently provide little revenue diversification. AM Best notes GCU's product innovation efforts by launching a fixed index annuity product in October 2021, but AM Best believes that GCU's risk management capabilities for this growing product have not been fully tested. AM Best notes that the society has strengthened certain aspects of its risk management framework since the global financial crisis in 2008, including enhancements to its cyber risk management and the formalized documentation of operational procedures related to investments. AM Best will continue to monitor GCU's progress in strengthening its risk management capabilities. The high degree of competition currently in the annuity marketplace is also a headwind toward execution of the company's business plan.

Protection of the Most Holy Mother of God

n my last article, entitled "Life Goes On," I wrote that from our infancy through old age, no matter what happens on our life's journey, the Holy Spirit gives us the strength to make it through all the conflicts and problems which we meet along the road of life. During this journey of life, however, there are times we need protection, so who can we turn to for this protection?

On October 1st of each year some Eastern Christian Churches celebrate the **Feast of the Protec**-

tion of the Most Holy Mother of God. This Feast can be traced back to the tenth century in Constantinople (now Istanbul). During the reign of Constantine VII, 913-959, the Saracens were trying to conquer Constantinople and had begun the decisive battle. The terror-stricken people gathered in various churches of the city to pray. In the Blachernae church near Constantinople, during the night services when the faithful implored the Mother of God for help, St. Andrew, the Fool for Christ's Sake, and his disciple, St. Epiphanius, saw the Mother of God appear in a cloud and pray with outstretched hands together with the people. Then, at the close of her prayers, she removed her beautiful veil *(omophorion)* from her head and held it over the faithful as a sign of her unfailing protection. The next day the city was freed from danger.

There are many ways God could have become a man, but he chose to be born of a woman who in her human nature, accepted completely the will of God, so that through her, God could enter our lives. In the Gospel story of the Marriage Feast at Cana, it was his mother, who interceded with Jesus, the second person of the Trinity, to make wine out of water, telling the stewards, and along with them, saying to all of us, "Do whatever he tells you." As his mother, she began the story of Jesus' mission, even though he had said, "My hour has not yet come." This truly is power given to her by God. This is still Mary's relationship with us. She is our protector and motherly intercessor. She is the mother of all believers. Our Lord, on the cross, gave her to his beloved disciple, John, and through him to all of

> us. Her message to us is still "Do what my Son tells you." This is why we can seek the protection of Mary, the Mother of God, and why we can sing, "Through the prayers of the Theotokos, O Savior, save us," and why we can even pray, "Most Holy Theotokos, save us!"

> Although this event took place a half a world away and more than ten centuries ago, the fact remains that "never was it known that anyone who fled to Mary's protection, implored her help or sought her intercession was left unaided" (St. Bernard). In reading the lives of the saints we notice again and again that they acknowledged Mary the loving mother as their intercessor who consoled, comforted and protected them. This Feast of her Protection celebrates the power of Mary, who fights on behalf of Christians, and is a mighty protector of the People of God.

Can You Do Me a Favor?

enjoy sharing on a regular basis—*Lessons in the Law*. The idea is to give you some insight on what you should be thinking about and how to make sure you have a valid estate plan.

Recently I was channel surfing the car radio and came across a program about estate planning. Since I have been working in this area for many years, I always want to hear what other people are saying about estate planning. I heard the presenter mention how the pandemic has caused three major problems in the estate planning area.

First, a recent study has shown that there are more people without wills than people having wills. The problem here is that if you don't have a will you must then follow your state laws. Your wishes may not be carried out and you may be surprised as to whom may inherit your estate.

Secondly, online wills became the source of many wills. The problem here is that many wills are not properly drafted and more often than not, these wills are not executed properly and witnessed. Therefore, these wills are invalid.

Thirdly, many wills cannot be found. Many people hide their important papers in a safe place that is so safe no one can find them.

Now I ask you to do me a favor.

Please follow this checklist:

- Make sure your will is current and updated.
- Make sure your will has been signed in front of two or three witnesses as required by your state.
- Please tell your family or friends where your will is located.

If you do these three things, chances are your will is valid and can be probated properly upon your death.





Ernest Mine Memorial

The Ernest Mine Memorial made some significant progress during the month of June. The sidewalks and some of the landscaping were completed with a grant from Indiana County Planning and Development. The work was done using the design plans of Tom R. Harley, Architects of Indiana, PA. Barb Hauge, who has been instrumental in the planning and design of the park, was on hand to help with creating footprints on the sidewalk indicating how the coal miners would stand and wait in line to pick up their paychecks at the Mine Office originally located on the site.

The foundation stones were left as a partial outline where the Mine Office once stood; however, there still needs to be additional landscaping work done to make the site safe for visitors. Once the final landscaping is completed, work will begin on completing additional work needed to complete the project. This includes metal silhouettes of miners that entered the mine that day, who are being memorialized at the site, educational informational signs about the mine disasters that occurred in Ernest in the early 1900's, several benches, and a memorial plague with the names of the coal miners who lost their lives in the two mine disasters.

It has also been discussed to contact local artists to paint a mural depicting coal mining life on the side of a garage that stands on the site. This has been a worthwhile project and although it is not yet completed, members of Lodge 351 will continue to work with Ernest Borough and the Ernest Coal Mining Committee group to see this project to completion.



If requests and all documentation are received after close of business on December 14, the GCU will work to complete the request by December 27, but cannot guarantee processing before year end.

Membership Requirements for all GCU Scholarships

To be eligible for all GCU scholarships, the student must be a member of the GCU by December 31, 2021 with either:

★ a permanent life certificate or ★ an annuity with a minimum balance of \$2,000.00

Membership requirements must be maintained throughout the application and award process in order to receive any scholarship award.

Opportunities for College Students

The National Scholarship is a \$2,000.⁹⁰ award for members five years and longer; members under five years \$1,500.⁹⁰ award:

- ★ are attending college (or other post-secondary education) as a full-time student
- ★ maintain a 2.75 GPA ★ meet all application and eligibility requirements

Along with an online application, applicants must submit:

- Collage of volunteer activity 🖈 photo
- ★ letter of recommendation from a parish priest, college chaplain or other clergy
- ★ Fall 2022 grade transcript (unofficial transcript accepted)

The Academic Performance Scholarship is a $1,500^{\circ\circ}$ award for members five years and longer; members under five years $1,000^{\circ\circ}$ award:

★ previously received the National Scholarship ★ maintain a 3.3 GPA as a full-time student ★ meet all application and eligibility requirements

This award can be received a total of four times; does not have to be consecutive years.

Along with an online application, applicants must submit:

Fall 2022 grade transcript (unofficial transcript accepted)

Opportunity for High School Athlete Seniors

The Athletic Scholarship is a \$2,000.00 award for one male and one female member who:

- ★ are high school seniors ★ participated in at least one organized sport
- ★ participated in at least one community service or volunteer activity
- ★ maintain a 2.3 GPA ★ will be seeking a degree program in the following academic year

Along with an online application, applicants must submit:

- tetter of recommendation from coach/instructor/organizer of each sport participated in
- tetter of participation from organizer of at least one volunteer activity participated in
- ★ school photo ★ current grade transcript
- ★ photo of student participating in sporting activity or in sports uniform

Applications for any of the above scholarships must be completed and submitted online in one session by 11:59 PM EST on December 31, 2022 to be eligible.

Once the online application is received and membership requirements are verified, the student will receive an email within 10 business days confirming acceptance of the application and requesting supporting documents be submitted by Tuesday, January 31, 2023. Applicants will receive a confirmation of receipt email for supporting documents.
