Welcome to the GCU Annual Report Issue

y article in the February issue of the *GCU Magazine* informed you that 2022 marks the 130th anniversary of the GCU as our Society was founded on February 14, 1892. In addition to our anniversary, through the Grace of God and oversight

of our Patron Saint, St. Nicholas of Myra, we can also celebrate the fiscal year of 2021 as being the most successful financial year in the history of the GCU.

GCU's total assets grew 9.7% in 2021 and now total \$2.4 billion. Surplus totals \$209.2 million representing a 14.6% or \$26.6 million increase. Net income after refunds and net capital gains/losses of \$33 million was recorded for year-end 2021, the highest ever recorded in the Society's history. A full detailed report and commentary by Chief Financial Officer Tim Demetres, is published on page 6. My sincere appreciation to our members and agents for the continued faith, trust and confidence you exhibit in the GCU—that is the cornerstone to the GCU's continued path of success!

In addition to the outstanding financial performance of the GCU in 2021, the GCU Holding Company, Inc. also experienced a substantial improvement. Seven Oaks Country Club, Inc. recorded the highest revenues in each area of the Club's revenue centers since it opened in 1978. Such revenue areas that experienced increases included dues, food & beverage sales, carts & green fees and golf pro shop merchandise sales reflecting an increase of \$988,200.00 compared to year end 2020. Coupled with the controlling of expenses a net profit before depreciation of \$223,600.00, was recorded. Please note that a Payroll Protection Plan Loan (PPP Loan) also assisted noting that this loan was forgiven. The improved financial position of Seven Oaks is attributed to the recent renovations to the Clubhouse and improvements to the golf course over the last several years. Unfortunately, the COVID-19 pandemic may have also played a role as families and individuals were seeking outdoor entertainment and a safe environment under the various concerns associated with this virus and restricted guidelines established by the Center for Disease Control and federal & state authorities.

The GCU Real Estate Company, Inc. also experienced activity in 2021 as three lots were sold. These lot sales

will improve the financial status of this subsidiary and will specifically have a positive impact on the balance sheet. Only seven lots remain in the Congressional Place single family development. Pinehurst Village, a multi-family home development within Seven Oaks, also experienced several sales in 2021. An additional four units are under construction with two units being pre-sold. This community is being constructed by Castlebrook Development. Additional information on the housing development will be presented in the June 2022 issue of the *GCU Magazine*.

Our Chief Operation Officer Scott Schuetz, will also be providing to you some insight of what is happening within the GCU, to better serve our members and agents, with a focus on the GCU's continued growth and digital transformation. Please review Scott's article on page 3.

Over the last several years, the GCU's Fraternal Programing on a National, Lodge and District level have been hampered by the COVID-19 pandemic. The safety of our members is first and foremost and decisions to suspend requirements were made in accordance with the Center for Disease Control (CDC) and federal & state guidelines. We will soon be giving the "green light" to our lodges and districts to return to a state of "business as usual"! We thank many of our lodges and districts that continued to provide fundraising and volunteer programing in support of their parishes and communities despite the pandemic challenges.

As we thought events couldn't get worse after experiencing the effects brought about by the worldwide pandemic, the war in Ukraine is now "center stage." We are once again witnessing death along with mass destruction of Ukrainian cities that I felt I would never see in my lifetime. It is heartbreaking to witness such devastation and the many families being displaced. Destruction not caused by a force of nature, but by Russian military invasion of this sovereign nation. This event certainly "hits home" as the very European roots of the GCU can be traced back to the first generation of immigrants migrating to the United States that came from the many villages located in the Carpathian Mountains of eastern Slovakia and western Ukraine.

In the last several years the GCU Foundation has solicited donations from our members to provide financial sup-

port to many organizations that have supplied much needed humanitarian relief to families and individuals suffering losses due to natural disasters and other causes. The most recent effort was in assisting the victims of the tornadoes that swept through the states of Oklahoma and Kentucky and the surrounding area in early December. The GCU's Board of Directors also committed Matching Funds to the many fundraising programs implemented by the Foundation. Soon after the war in Ukraine began, the GCU Foundation once again launched a fundraising campaign to support the humanitarian efforts so deeply needed. We are so pleased to announce that through the generosity of our membership and the \$50,000.00 Matching Funds commitment of the GCU's Board of Directors, \$118,328.00 will be distributed amongst the Ukrainian Catholic Archeparchy, United Help Ukraine and the Slovak Greek Catholic Eparchy of Kosice. The funds raised for this effort are the most ever collected for a Special Match. On behalf of the GCU Board of Directors and the people of Ukraine, we thank you for your generosity!

As I announced in the last issue of the *GCU Magazine*, I will be presenting some "tidbits" of historical information in each of my articles. From our humble beginnings and noting a multitude of accomplishments and challenging events that occurred that GCU successfully navigated through, in celebration of the organization's 130th Anniversary.



Did You Know? Our Humble Beginnings

- The initial death benefit was set at \$400.00 per member.
- Annual conventions were held as delegates from each lodge attended setting the course of the GCU and its future. The Conventions were initially established as the supreme ruling body of the GCU.
- Discord among delegates at the sixth Convention held in Johnstown, Pennsylvania led to a faction of GCU defeated members running for office and members of three lodges establishing a new organization, the "Sobranije" or the United Societies of the U.S.A. founded on March 29, 1903.
- The official newspaper of the GCU was titled the "Amerikansky Russkij Viestnik" (ARV), in English the "American Rusin Messenger." This publication provided very informative articles that were beneficial to the arriving Rusin immigrants to the United States. The Kalendar (Yearbook) was an annual publication of the GCU. I recall in my youth, my Dad would ask my Mom if we received the "Viestnik"?
- The first editor of the GCU was Paul J. Zatkovich. The operations office, newspaper office and printing plant were located in Mahanoy City, Pennsylvania from 1892 through 1896. The entire operations moved to Scranton, Pennsylvania in 1896 and soon thereafter relocated again to New York City.
- After five years of existence, Greek Catholic parishes grew from one in 1894 to thirty-three in 1898 with 152 GCU Lodges established with 6,776 members.
- By 1902, GCU assets topped \$22,700.⁰⁰.
- In addition to life insurance, the GCU also provided for the payments of disability benefits to eligible members that began to be paid in 1899.
- In 1902 the GCU fell upon hard times ten years into its existence as claims exceeded assets. Strong leadership under President Michael Yuhasz, initiated bylaw revisions and a strong membership campaign organized around the feast of St. Nicholas which were successful in revitalizing the GCU and saving the Society from insolvency.

2021 Financial Results

A Year Highlighted by Financial Growth & Strength

The year 2021 was exciting for GCU in terms of growth, financial strength, and credit rating improvement to A-. GCU also introduced the Aquila X, a fixed indexed annuity product. GCU continues to grow with total assets exceeding \$2.4 billion and surplus surpassing \$209 million as of December 31, 2021.

Highlights of 2021

Income before net capital gains (losses) totaled \$32.8 million in 2021 compared to \$29.7 million reported in 2020. Net income after realized capital gains (losses) was \$33 million in 2021 compared to \$12.8 million in 2020. In 2020, we recognized \$16.9 million in impairments from certain energy related investments.

Total Assets increased \$213 million to \$2.414 billion in 2021 from \$2.201 billion in 2020. The increase in assets reflects continued growth in invested assets from new business activity and positive cash flows. We employ a diversified asset allocation strategy to generate appropriate risk adjusted returns in support of our life and annuity liabilities. A key objective of this strategy is to complement fixed income returns by modestly increasing exposure to alternative assets (investments in LLC's and limited partnerships), real estate and public equities to less than 5% of total invested assets.

Liabilities grew commensurate with increased life and annuity sales and totaled \$2.205 billion as of December 31, 2021 compared to \$2.018 billion at year-end 2020. The \$186.4 million increase in total liabilities is due primarily to a \$169.1 million increase in life and annuity reserves, a \$15.5 million increase in AVR, and a \$1.4 million increase in the IMR from deferred investment gains.

Total Income in 2021 grew to \$423.8 million, an increase of \$69 million compared to \$354.9 million in 2020. Life sales increased 75% from growth in our whole life single premium and final expense products. Annuity sales and exchanges increased \$51.9 million to \$291.6 million in 2021. Net investment income increased \$13.5 million to \$116.9 million from growth in invested assets and income earned from makewhole premiums on bond calls and tender offers.

Operating expenses, before the increase in reserves, totaled \$225.3 million versus \$190 million in 2020, an increase of \$35.3 million or 18.6%. Largely attributable to meeting the needs of our members, GCU paid \$30.1 million more in annuity benefits (death claims, full and partial withdrawals). Annuity exchanges decreased \$6 million. Commissions paid agents increased \$7.3 million commensurate with higher life and annuity sales. General insurance expenses were \$1.6 million higher in 2021 when compared to 2020 due to increased depreciation of EDP equipment and software. Pension expenses increased \$1.2 million due to employee attrition and pension distributions. The higher pension expenses were mostly offset by a decrease in the pension fund liability resulting in a minimal impact to net income.

The increase in reserves totaled \$165.4 million in 2021 compared to \$134.9 million in 2020. Reserve changes are primarily a function of premiums received, death claims and annuity benefits, and interest accumulation.

Surplus grew to \$209.2 million in 2021 compared to \$182.7 million at year-end 2020. The \$26.6 million increase in surplus is attributable to the additions of net income and the change in unrealized gains of \$33 million and \$11.2 million, respectively, reduced by the change in AVR (\$15.5 million); (\$1.6 million) increase in non-admitted software development costs; and (\$0.5 million) reduction for GCU Holding Company's net loss.

Total Adjusted Capital (TAC) was \$233.2 million at December 31, 2021. TAC starts with surplus of \$209.2 million and adds back the asset valuation reserve of \$23.8 million and one-half the dividend liability of \$150,000. TAC is a financial strength measure closely monitored by rating agencies. The solvency ratios based on TAC were 110.7% and 109.5%, as of December 31, 2021 and 2020, respectively. These strong ratios reflect GCU's excellent financial strength.



Some Customs & Traditions of "Easter"

or ten weeks now through prayers, liturgical services, and our personal fasting we have been preparing for the glorious day of Christ's Resurrection, Pascha or Easter Sunday. Hoping that during Lent everyone had an opportunity to be cleansed from his or her personal sins, the Church now celebrates externally and with beautifully joyous ceremonies the final triumph and life-giving resurrection of our Lord and Savior, Jesus Christ. Various peoples, through their different customs and traditions, are now ready to celebrate the Glorious Resurrection of our Lord. I would like to point out a few of the customs, traditions, and liturgical actions, along with their meaning, which have been passed down to us from the Carpatho-Rusyn region of Eastern Europe, from which the GCU founders and ancestors came.

IS IT "EASTER" OR IS IT "PASCHA"? The term "Pascha," in its traditional application, has several meanings: "Pascha," the Greek form of the Hebrew word "pesach," meaning "to pass over," is a Jewish holy day, which commemorates the liberation of the Jews from Egyptian slavery and their crossing over the Red Sea into the Promised Land. Through Christ's Resurrection we have passed from the slavery of sin and "from death to life," and "from earth to heaven" (Jn. 5:24; 14:1). At Resurrection Matins we sing: "The Passover is the Lord's Passover, since Christ our God has brought us from death to life and from earth to heaven" (Irmos of the First Ode). For us the word "Pascha" indicates the yearly commemoration of Christ's glorious resurrection. In the Liturgy "Pascha" is described as the "feast of feasts and solemnity of solemnities" (Irmos of the Eighth Ode). In other words, Easter is simply called Pascha. The Easter Canon refers to Jesus Christ as our Pascha since He "willingly sacrificed Himself like a yearling lamb for all of us" (Troparion of the Fourth Ode). We use the similar term "Paska" for the bread we bless in our "Easter baskets," representing Christ the living bread.

WHY DO WE STAND AND NOT KNEEL FROM EASTER TO PENTECOST? During all the liturgical services in church, and even in our private prayers at home we stand and do not kneel. Kneeling, [and prostrating] is a penitential posture. It is the position of a sinner seeking forgiveness. It

is not a position of adoration as it is in the West. Standing, the proper position of adoration in the East, is the position of giving praise and thanks to God. During the Paschal Season the time for repentance and fasting is over. It is the time of our salvation for "Christ is Risen!" We express our joy, thanksgiving, and adoration for this fact and the fact that we who have been "...baptized into Christ and put on Christ" have also risen with Him. It is for this reason that kneeling is improper during this holy season. To kneel is to imply that we do not accept the resurrection of Christ. By standing for all prayer, in church and at home, we are demonstrating in a bodily way that we believe that "Christ is risen from the dead, by death He trampled death and to those in the tombs He granted life."

ICON OF THE RESURRECTION: All four Gospels are silent on the manner of Christ's Resurrection. Nowhere in sacred Scripture is there a factual account of the event. Byzantine art is faithful to the Gospel and never presents this event, but it expresses what occurred before or after the Resurrection. The Icon of the Resurrection is either the "Descent into Hades" or the "Myrrh-bearing Women." The Icon of the Descent into Hades shows Christ as the Life-giver. In it, Christ is seen trampling the gates of Hades and taking Adam and Eve by the hands and drawing them to life.

BLESSING OF EASTER BASKETS: One of the most popular customs is to bring to the church hall, or other appropriate place, the food that we have fasted from during Lent. For those who keep the traditional "strict fast" it would mean any meat or dairy products that they fasted from for the forty days. Some of these foods could include EGGS—Brightly decorated eggs (pysanky) are a symbol of the New Life that is ours in Christ. PASKA (Easter Bread)—A sweet, yeast bread rich in eggs, butter, etc.

SPIRITUAL

Symbolic of Christ who is our True Bread. HAM—Celebrates the freedom of the New Law which came into effect through Jesus' resurrection, in distinction to the Old Law which forbade certain meats. Lamb or veal are also used. CHEESE (Cirec or Hrutka)—A custard-type of egg cheese shaped into a ball having a rather bland but sweet taste indicative of the moderation that Christians should have in all things. HORSERADISH—It reminds us of the bitterness and suffering of Christ which culminated in the Resurrection. BUTTER (Shaped into a figure of a Lamb)—The lamb is the ancient Passover food by whose blood the Israelites were saved. Jesus is our Paschal (Passover) Lamb by whose blood we are saved.

I have presented some of the traditions of the Slavic peoples whose ancestors came from the Carpatho-Rusyn region of Eastern Europe. I am sure that in your own families you have other traditions and customs. Those who have come from other nationalities will have their own customs and traditions. All of these are important to us, and the joining together of the various customs allow us to relive and celebrate the magnificent event of Christ's Resurrection that has given us eternal life.

It's a cloudy morning as I write this report just in time for the March 25 deadline. I can hear the birds chirping and the whistle from a train on the banks of the Ohio River not far from my home in Moon Township, PA. It's peaceful here; I don't take peace for granted these days.

Thoughts & Prayers For Ukraine | In the first week of Russia's invasion of Ukraine, I watched for reports and updates with hopes that the conflict would end quickly and that the troops would return to their own country. My husband, John, our children and I have many friends with family still in Ukraine-mostly in and around Lviv. Some hiding in the basements of their homes; some have fled to safety in Poland; and still others of whom we know nothing.

Friends and family attended peace rallies here in Pittsburgh; made monetary donations; flooded Facebook pages with sunflowers and details about Ukraine's right to sovereignty; and my son John, has helped pack boxes of supplies for the people of Ukraine. Like many others, I followed the story of Rev. Charest, the local priest who traveled to Ukraine in the first weeks of the war to rescue 22 children from an orphanage and I said a prayer of gratitude upon reading of his success.

The images of the refugees, many of them children, haunt me. Forced to leave their homes, schools and jobs for the unknown. Will they reach safety? How will they be received? Will they be able to find peace in a new country?

I am inspired by the courage of the Ukrainian people and was reminded of the courage of my grandparents, who also fled Eastern Europe for the unknown. John and I have talked about just that in recent weeks. How incredibly blessed we are to have had grandparents with the courage to leave their homeland for the unknown. GCU was founded by people with that kind of courage over 130 years ago. We are all blessed! As part of St. Andrew the Apostle Church in Westbury, NY continuing adult education program, Sr. Katarina OSB presented the topic on Our Lady of Czestochowa on Sunday, February 20. Support of Ukraine Orphanage

When Father Vladyslav shared his feelings and actions he took in response to the invasion of Ukraine, he had hoped others would join him. The response though has been much wider than he imagined. Being here in Smithtown NY, while his country and hometown of Chernihiv, where his parents still live, were under attack, father felt he had to act in some way to help. He contacted a fellow priest he knew who is in Ukraine and quickly decided to help provide support for an orphanage there, which has become a place of refuge for women and children from the war zone. Father sent them his entire salary for the month to help support them. The parish shared father's letter on their Facebook page. Soon the local Rotary stepped forward with a large donation for the orphanage. Next, the teachers and staff at the school where father's children attend here on Long Island took up a collection for the cause. All the while, parishioners and Facebook followers also stepped up to help.

Still torn by the violence he saw, Father felt compelled to do more, so he wrote to local elected officials, urging them to take stronger decisive action to help end the violence and death occurring in Ukraine. One elected official asked Father's permission to share his letter with one of the New York newspapers. This resulted was an article being published, sharing father's actions. Which in turn lead to more people contacting the parish and donating to the orphanage. Finally, from the newspaper article, the Long Island cable news network took note. They interviewed Father Vladyslav and aired a short story about father, his parents still in Chernihiv, the violence and destruction and Father's efforts to help the orphanage. Through this even more people on Long Island were reached and touched, resulting in still more people sending support for the orphanage. Currently, the parish has provided over \$23,000.00 to the orphanage.

22nd Annual Saints Cyril & Methodius Lecture

The Rev. Dr. Radu Bordeianu will deliver both in person and through livestream the 22nd annual Ss. Cyril & Methodius Lecture of the Byzantine Catholic Seminary entitled "The Church as a Family."

Saint John Chrysostom wrote that "the house is a little Church." Indeed, Christian upbringing begins in the family, where the spouses are priests for each other and they dedicate their children to God. As any other family, the Church has many types of members. Some are active in their parishes, some hold different beliefs (mixed marriages), some are only culturally Christian (they are no longer active, but identify with a certain church), while others are "nones" because they do not belong to any church. In a deeper sense, however, all are members of the diverse family that is the Church.

The public is welcome to register for and attend this lecture on Thursday, May 12 at 7 PM at Saint John Cathedral Center in Munhall, PA. The lecture will be livestreamed via the Seminary website (www.bcs.edu) and recorded for future access by the public on the Seminary YouTube archive. The Seminary website also has registration information for those who plan to attend in-person. This event is free but due to space limitations, registration for in-person attendees is required by Thursday, April 28.

Fr. Radu Bordeianu is an Associate Professor of Theology at Duquesne University and assistant priest at Holy Trinity Greek Orthodox Church in Pittsburgh. His research focuses on ecumenical dialogues and various teachings on the Church. He is the author of Dumitru Staniloae: An Ecumenical Ecclesiology (2011, Romanian translation 2022), and the editor of It is the Spirit Who Gives Life: New Directions in Pneumatology (2022). He served as President of the Orthodox Theological Society of America and is currently a member of the North American Orthodox-Catholic Theological Consultation – the official dialogue between the two churches. He is a co-convener of the Christian-Jewish Dialogue in Pittsburgh and is involved in local ecumenical dialogues.

The annual lecture series is sponsored by the Byzantine Catholic Seminary of Ss. Cyril & Methodius in Pittsburgh, PA, a community of mentors, teachers and students living and working in an ecumenical environment of Christian unity, integrity and missionary spirit.

Founded in 1950, the Byzantine Catholic Seminary is a free-standing, English speaking theological seminary, welcoming all those seeking the knowledge possessed by the Eastern ecclesial traditions. The Seminary is authorized to grant the Master of Arts in Theology and Master of Divinity degrees by the Commonwealth of Pennsylvania and is accredited by the Commission on Accrediting of the Association of Theological




