Did 'ya Ever Wonder...

am not a huge television fanatic, but I do enjoy watching sports, especially the Miami Hurricanes, along with local & national news and reruns of Miami CSI & Columbo. On occasion I also enjoy watching MeTV (Memorable Entertainment Television) offering a variety of classic television programs from the 1930s through the 1990s. My favorite news program continues to be 60 Minutes. First airing on September 24, 1968, it is the oldest and most-watched news magazine on television-reporting on America's most prevalent topics ranging from hard news coverage to politics, lifestyle, pop culture, business, health, and science. Although the various segments of the program were extremely informative, my favorite was "A Few Minutes with Andy Rooney" as he typically offered satire on everyday issues. He would often start his commentary with "Did 'ya ever wonder?"

Being a "Baby Boomer" and sharing with you my favorite shows I grew up with, "Did 'ya ever wonder..." what happened to the good wholesome shows that in many ways taught a lesson at their conclusion? I would welcome back the days when three networks broadcast and were received via TV antennas, concluding at midnight with the playing of our National Anthem. Today's sitcoms and other reality shows, many portraying no morality or comedic relief, just don't resonate with me. Maybe I'm just showing my age or being "grumpy" like Mr. Rooney!

Well, enough of that but I would like to place a little Christmas into my observations. "Did 'ya ever wonder..." how the poinsettia came to be as a Christmas plant. Here are some fun facts about its history.

- The poinsettia flower is native to Central America specifically, an area in southern Mexico called "Taxco del Alarcon."
- It wasn't until the 17th century that the plant first became associated with Christmas when Franciscan monks in the town of Taxco de Alarcon used the shrub in Nativity processions.
- The plants were used by the ancient Aztecs to make a purple dye for clothing and cosmetics.
- A medicine to treat fevers was made from the poinsettias' milky white waxy sap.
- Contrary to popular belief, poinsettias are not poisonous. While some humans and pets are sensitive to the plant's milky white sap, which contains latex, it is not tox-

ic. It can, however, cause irritation to the skin, eyes, mucus membranes or digestive system if consumed. Well, maybe it is poisonous!

- The showy, colorful part of the poinsettia is not a flower, it is a modified leaf. The poinsettia's modified leaves called bracts, are often mistaken for the flower. Actually, the small yellow flowers called cyathium, can be found clustered in the center of the bracts.
- Poinsettias can grow up to 15 feet tall. In their native tropical environment in Mexico and Central America, poinsettias are a perennial woody shrub that grow as high as 10 to 15 feet tall, more like a small tree than a houseplant.
- December 12 is National Poinsettia Day. The date marks the death of Joel Roberts Poinsett, the South Carolina congressman credited with bringing the poinsettia to the United States from Mexico. The U.S. House of Representatives passed a measure recognizing National Poinsettia Day in 2002.
- California is the top poinsettia-producing state. Poinsettias are commercially grown in all 50 states. Other top poinsettia-producing states include North Carolina, Texas, Florida and Ohio.

I am sure "**you are wondering**" how the GCU is performing financially. Despite the challenges associated with the current high interest rate markets, GCU is performing well, continuing to increase assets and surplus and generating a modest net profit. Assets for the first nine months of 2023 stand at \$2.7 billion, surplus totals \$220 million with a recorded net profit of \$7.4 million. The GCU's 2023 third quarter financial results and detailed commentary are presented on page 6 by our Chief Financial Officer Tim Demetres.

As we are concluding the first full year under the GCU's new Fraternal Metamorphosis Program, our gratitude and thank you to each of our Constellation and Byzantine Catholic Parish Coordinators. We view this new format as a total success as we have expanded the GCU's presence in many new communities and our Byzantine Catholic Parishes having more than doubled the number of parishes that had lodge affiliation in the past. Our special thank you to the GCU's Fraternal/Communications Director, Basil Wahal, and his entire Staff for their efforts in assisting the coordinators. Their efforts

have brought many new GCU faces to the various fraternal activities that were planned throughout the past year.

GCU Presents Annual Byzantine Seminary Educational Grant

Life Insurance The Gift That Keeps on Giving

ith the holiday season fast approaching, it is a good time to reflect on what we are thankful for. As I take a moment, I know that I am thankful for my family,

grandkids and all of my friends, my health, and I am also thankful that I am lucky enough to work for GCU, a Fraternal Benefit Society. Yes, GCU offers Life Insurance and Annuities,

but we are so much more than that. We have members whose families have been part of GCU for 3 or 4 generations, some families even longer. They have stayed with GCU because they know that we will be here when they need us the most.

Let's talk about how life insurance can be the "Gift that keeps giving."

GCU offers two different whole life insurance policies that allow you to add a special rider. The two policies are the GCU Legacy Advantage and the Legacy Advantage 20. To keep things simple, I will use Legacy Advantage 20 to make my point.

Let's assume that grandparents want to buy life insurance for their 2-year-old grandson. The annual premium for a \$25,000 policy is \$205. Because they selected the Legacy Advantage 20, the policy will be paid up in 20 years, when their grandson turns 22. They also decided to add a Guaranteed Insurability Option rider to the policy, which increased the cost of the policy by \$10 more per year. This rider will allow the grandson to get additional insurance several times during his lifetime, regardless of his health. His first opportunity to get more insurance is at

> age 22. So, he gets another \$25,000 policy that costs him \$335 per year! He now has \$50,000 in total coverage. This new policy also is paid up in 20 years. He can also purchase more insurance at the following ages, 25, 28, 31, 34, 37 and 40. All once again because of the Guaranteed Insurability Rider. He can also use the rider if he gets married or has children.

> If the grandson uses the rider to purchase more coverage 2 more times, he will have \$100,000 of whole life coverage all without needing to prove insurability. He has a great life insurance plan in place, all because of the wisdom of his grandparents. They gave him a gift that will keep on giving even long after they are gone. This holiday season, think about the gift of life insurance.

GCU Board of Directors Election Process & Declaration of Candidacy

Board Election

With the approval of the GCU Referendum in April 2018 eliminating the need for a National Convention, a new election process was developed to elect the ten (10) members of the GCU Board of Directors. Ballots will be mailed to all Adult GCU Benefit Members (18 years of age and older) on Monday, June 3, 2024. Members will have the ability to vote by mail or online, once they have received their ballot. Each vote carries the same weight and there is no proxy voting.

Candidates that meet the following criteria, may submit their Declaration for Candidacy until Monday, April 1, 2024. Declaration of Candidacy forms are available on the GCU website in the Member Events section or can be obtained by calling GCU President/CEO George Juba at 724-495-3400 ext. 3928 or emailing gjuba@GCUusa.com.

Summary of Directors' Responsibilities

As a member of the GCU Board of Directors, a Director is responsible for the effective governance of the GCU. Their main purpose is to advise, govern, set and oversee policy & direction, and assist with the leadership and general promotion of the GCU in support of its mission, strategic vision and core values.

Bylaw Requirements

As per Par. 62 of the GCU Bylaws, **all** candidates for Director must submit a Declaration for Candidacy & Resume Form for Director together with a digital photograph and comply with the following qualifications:

- (a) A citizen of the United States of America.
- (b) A member of the GCU for a minimum of five (5) years as of January 1 of the election year.
- (c) A person of Slav origin and a Byzantine Catholic for a minimum of five (5) years as of January 1 of the election year.
- (d) Of good moral character, reputation and good American spirit.
- (e) A candidate must have attained the age of 30 prior to January 1 of the election year and not be older than age 77 prior to January 1 of the election year.
- (f) Any other qualifications set forth by the Directors in the Declaration of Candidacy & Resume Form for Director.

Qualifications as set forth by the Board of Directors per Par. 62 (e) are as follows:

- Must possess a minimum of two of the following:
 - Bachelor's degree or higher from an accredited university.
 - Currently hold (or has held) an executive or C-Suite position for a minimum of five years in the insurance, annuity, financial, or fraternal industry.
 - Owns and operates (or has owned and operated) a successful middle market business enterprise for a minimum of five years.
 - Currently employed or has been employed in the financial/insurance industry for a minimum of five years or possess a financial/insurance certification for a minimum of five years.
 - Serve (or have served) as a Director on a professional policy, carver or governance Board for a minimum of five years.
 - Minimum of five years experience in human resources, risk management, cybersecurity or digital marketing.

Expectations of Board Members

- Be committed and possess values that are aligned with the purpose and mission of the GCU.
- Solid understanding of the GCU's business.
- Contribute to the improvement of Board Governance though knowledge or skills possessed in one or more of the following areas: policy, finance, organizational strategy, technology, legal, marketing, sales, civic leadership, risk management or personnel.
- Gain understanding of the GCU's policies and procedures.
- Become familiar with the GCU's finances, budget, and financial/resource needs.
- Participate on standing committees of the Board and serve on ad-hoc committees, as necessary.
- Prepare for and participate in the discussions and the deliberations of the Board.
- Be alert to community concerns that can be addressed by the GCU's mission, objectives, products and programs. Communicate this to the entire Board.
- Foster a positive working relationship with other Board members.
- Be aware of, and abstain from, any conflict of interest.

Key Responsibilities

Members of the Board shall share these responsibilities while acting in the best interest of the GCU. Each member is expected to make recommendations based on their profession, experience, expertise and vantage point in the community.

- Organizational leadership and advisement.
- Formulation, oversight and governance of policies and procedures developed by the Board.
- Establish overall long and short term goals, objectives and priorities for the GCU.
- Recommend GCU policy.
- Prepare for and participate in the discussion and the deliberations of the Board.
- Financial oversight, including approval and oversight of the annual operating budget.
- Oversight of program planning and evaluation.
- Monitor and evaluate the effectiveness of the GCU's annual business plan through a regular review of sales and budget reports as well as a review of products, programs, and services as compared to the market and competitive environment.
- Review of key departmental (finance, membership, sales, marketing, fraternal) plans, budgets and performance reports.
- Promotion, and support thereof, of the GCU's membership and mission through advertising, outreach and community networking.

Meeting and Time Commitment

- The Board of Directors meets quarterly with a minimum commitment of 15-20 days on site annually, not including travel time.
- In addition, Board members are to be available at the call of the Chairperson of the Board for any committee and special meetings. These meetings may be either in person or via teleconference, throughout the year.
- Board members are expected to attend GCU events and meetings.

Term

Directors are elected by the membership to a four-year term beginning on October 1, 2024 through September 30, 2028 .

2024 GCU Board Election Timeline

December 2023—Declaration of Candidacy Form available on GCU Website. Election announced in *GCU Magazine*.

February 2024—GCU Board Election announced in *GCU Magazine*.

April 1, 2024—Declaration of Candidacy and supporting documents must be postmarked and sent to GCU Home Office for consideration and approval of Nominating Committee.

May 1, 2024—All applications, upon approval by Nominating Committee, will be submitted to Broadridge Financial Solutions, Inc.

June 3, 2024—Ballots mailed to members.

July 1, 2024—Balloting closes online; mailed ballots must be postmarked and returned.

CFO REPORT

Third Quarter 2023 Financials

s we move forward to close out 2023, the rising interest rate environment appears to have crested. The swift rise in rates rapidly reshaped one of the significant benefits fraternal organizations provide to their mem-

bers, higher interest crediting rates on annuities. These benefits are designed to provide safety and security for those planning for retirement as well as creating wealth over the long-term. Crediting rates ebb and flow in unison with economic cycles.

While we carefully navigate the economic challenges in 2023, I am pleased to present GCU's financial results for the nine months ended September 30, 2023.

GCU's total assets increased \$51 million to \$2.69 billion and surplus strength was maintained increasing \$1 million to \$220.2 million. Total adjusted capital increased \$5.7 million to \$244.2 million as of September 30, 2023 compared to \$238.5 million as of December 31, 2022.

Income before net realized capital gains (losses) totaled \$8.1 million for the nine months ended September 30, 2023, compared to \$15.4 million reported in 2022. The net gain from operations was lower in 2023 primarily due to increasing annuity crediting rates and lower net investment income from increased outflows on annuity products. Net income after realized capital gains (losses) was

\$7.4 million in 2023 compared to \$18.7 million in 2022. We had \$664 thousand in net realized losses in 2023 and \$281 thousand net gains in 2022.

The increase in Total Assets primarily reflect increases in invested assets: bonds; alternative assets; cash and derivative assets.

Liabilities totaling \$2.47 billion on September 30, 2023, increased relative to life and annuity sales. The \$51.9 million increase in total liabilities is due primarily to the \$45.9 million increase in life and annuity reserves reflecting new sales, interest credits and surrender activity, a \$5 million increase in Asset Valuation Reserve (AVR), offset by and a \$1 million decrease in the interest maintenance reserve (IMR).

Total Income was \$366.0 million through September 30, a decrease of \$26.7 million compared to \$392.6 million in 2022. Annuity new business sales remain strong although lower than last year. Net investment income increased modestly to \$88.2 million.

Operating expenses, before the change in reserves, totaled \$311 million versus \$180.3 million in 2022, an increase of \$131 million 72.6%. GCU disbursed \$89.1 million more in annuity benefits for death claims, full and partial surrenders. Annuity exchanges increased \$43.2 million. General insurance expenses were \$1.1 million higher in 2023 when compared to 2022 primarily due to the timing of when certain fraternal activities are funded.

The change in reserves totaled \$46.4 million in 2023 compared to \$193.7 million in 2022. Reserve changes are a function of premiums received, death claims, annuity benefits paid and interest accumulation.

Surplus on September 30, 2023, increased \$0.7 million to \$220.2 million versus year-end at \$219.5 million. The changes

in surplus reflect the addition of net income and unrealized gains totaling \$7.3 million offset by decreases of \$5 million to fund additional AVR and \$1.6 million for non-admitted assets and the net loss of GCU Holding Company, Inc.

Total Adjusted Capital (TAC), a risk metric used by regulators and rating agencies, increased \$5.7 million to \$244.2 million as of September 30, 2023, from \$238.5 million on December 31, 2022. TAC starts with surplus of \$220.2 mil-

lion and adds back the asset valuation reserve of \$23.9 million and one-half the dividend liability of \$155,000. The solvency ratios based on TAC were 110.0% on September 30, 2023 and 109.9% at December 31, 2022. These ratios reflect the stability of GCU's financial strength.

Traditions & Customs

ear Friends:

As many of you know, part of my childhood, growing up was in what we call "staryj kraj-old country." It was there that I was given the opportunity to learn, understand, and embrace all of our venerable traditions and customs.

What comes to mind when you hear those words "traditions" or "customs"? Well, I must say that even in Pittsburgh we have traditions that make our city unique (and I mean it).

Attending wedding receptions in Southwestern Pennsylvania you admire our cookie tables which are a cherished Steel City tradition that span generations. For many individuals and families attending "First Night" to welcome the New Year has become an annual tradition, or when most amusement parks close down when the weather turns cold, many people have the tradition of going to Kennywood, which stays open for its annual Holiday Lights event. And who cannot admire the tradition of the "Terrible Towel" in action. Since 1975, thousands of fans swing that Terrible Towel as a rallying cry at Pittsburgh Steeler games, but also as a sign of being a true Pittsburgher. These are the traditions that I have embraced and learned to love for over 25 years.



But what about our venerable traditions and customs that we have had for centuries in our Byzantine Catholic Church. Do we know them? Do we understand them?

In our Holy Church, Holy Tradition is the deposit of faith given by Jesus Christ to the Apostles and passed on in the Church from one generation to the next without addition, alteration or subtraction. That means nothing gets added, nothing gets changed, and nothing gets removed. The theologian Vladimir Lossky famously described Tradition as "the life of the Holy Spirit in the Church." It is dynamic in its application, but unchanging in its doctrine. It is growing in expression, yet always the same in its essential meaning.

Alongside Holy Tradition, we also have various customs that help us to express the Holy Tradition-these are things like how certain feast days are celebrated, the exact nature of fasting rules, or details of the Church calendar. These things can change over time, and they have in the life of our Byzantine Catholic Church, and that's okay. What's important is that the Holy Tradition given by Jesus Christ remains the same.

In several of our parishes, till this very day, we enjoy the St. Nicholas visit. In the old country, St. Nicholas on his feast day traditionally goes from house to house in the village with his "helpers". Who are these helpers? His close helpers are the angels, but somewhere in the background you would also see the little devils trying their best to cause trouble for the children of the household. I remember as a child I was always afraid of the "devil" until I recognized one of my cousins playing that role. As part of the St. Nicholas visit he would ask you if you know your prayers, if you help around the house, or if you are good in school, and then you would receive your small gift-great memories.

Growing up Byzantine Catholic, fasting played an important role in our family. As part of our preparation for "Velija", that is the Christmas Eve Holy Supper for years



we had to get the live "kapor-carp". This is something I enjoyed as a boy. My sister usually freaked out walking into the bathroom and seeing the live carp in our bathtub! I took it upon myself to even feed the hungry fish, knowing well what's going to happen on Christmas Eve. Nowadays I'm satisfied with a well-prepared tilapia.

Velija – Holy Supper was a sacred time for us. Waking up on Christmas Eve morning with the aroma of mushrooms, cabbage, pots boiling on the oven, all these family traditions that for generations that have kept Christ at the center of Christmas. Then, with the appearance of the first star sitting down at the table (with hay underneath), reading the Nativity Gospel narrative, offering prayers, singing Christmas carols and enjoying the Holy Supper that consisted of twelve meatless dishes representing the twelve Apostles. The only part I always struggled with was the garlic. Until this day I just can't do the garlic.

Friends, for centuries our Holy Church has given us a beautiful tapestry of Christmas traditions/customs which point to Christ. This time of the year I urge you to keep them alive in your household and in your parish family. If you are not familiar with these traditions/customs maybe it's time for a workshop in your parish. If you visit the GCU Website and select the About GCU tab you will see at the top of the list History & Heritage. Click on this and go to the bottom of the page there is a copy of a flier about Christmas Eve traditions as well as one for preparing a traditional Easter Basker for Blessing.

It is awesome that we do have our traditions/customs, but do we understand them? Simply mimicking what people of the past did isn't enough. We need to internalize them and make them part of who we are as Byzantine Catholics. Understanding why we keep certain traditions/ customs, and how it is that they have led people in the past to God, and how they can lead us closer to God today, is absolutely essential to our faith. My friends, keep our traditions/customs alive!

This year, as we look up at the Star of Bethlehem with hope for our future, we join our brothers and sisters worldwide singing those words: "God is with us! Understand, all you nations, and submit yourselves, for God is with us!"

I thank you for your love and prayers. Let us hold one another in our prayers, especially our brothers and sisters in the Middle East and Ukraine. May our Lord Jesus Christ, born in Bethlehem, bless you, your families, and loved ones at this blessed time of hope and grace.

Christ is born! Glorify Him! Christos Raždajetsja! Slavite jeho!

Lessons in the Law

When Your Will Does Not Work

wo issues ago, I wrote about how your Will may not work the way you wrote it. It prompted some questions as to whether you need a Will or not. The simple answer is yes everyone needs a Will. If you have an asset that does not have a beneficiary then your Will controls who would inherit that asset. There are many instances

where people think they have beneficiaries named on everything and there may be a couple you forgot about.

Now is the time to review all of your assets and review how they are titled and whether you named a beneficiary or not. I've been recommending for years that people do this. A few years ago I decided to follow my own advice and found out that I had some assets with no beneficiaries listed. When I researched this issue, I found out that the beneficiary information was lost by the company.

The next question that was raised was should I have a

Trust instead of a Will? My answer is maybe. That is why you need to review your estate plan and determine what is in your best interests. There is a little more work in drafting a Trust which includes drafting the documents and possibly funding the Trust now. That means transferring your assets into the Trust and then the Trust controls your assets during your lifetime.

I would suggest that you make an appointment with an attorney who concentrates in this area. You don't want an attorney who specializes in personal injury cases writing your Will or Trust.

Remember a good estate plan includes a Will, maybe a Trust, a Living Will and Durable Powers of Attorneys for health and finances.

Cantor Kevin Beres Retires After 50 Years of Service to St. John Chrysostom Church

There are times when "thank you" just doesn't seem to be sufficient. That was the case on Sunday. September 10 when St. John Chrysostom parish community celebrated the 50-year career and retirement of our beloved cantor, Kevin Beres. As one priest stated Kevin is "one of the best [cantors]" and we could not agree more. Following Divine Liturgy on September 10, Fr. Miron Kerl'-Kmec presented Kev-

in with the icon *Synaxis of Holy Chanters and Hymnographers.* The parish family then gathered in the social hall for a light lunch and cake and an opportunity to personally thank Kevin for his many years of service.

At the age of 14 Kevin expressed to his mother a desire to sing with the parish cantor Mr. Frank Kostilnik. She encouraged Kevin to talk with the cantor and as they say, the rest is history. Frank Kostilnik welcomed the enthusiastic teenager to the cantor's podium, and Kevin began singing with him. He joined Michael Roman who chanted the Epistle in Church Slavonic and John "Lefty" Lopata who chanted the "Viruju" – the Nicene Creed–in Church Slavonic.

But Kevin's training began much earlier. He always loved singing along with 45s on his record player. He sang in grade school where he learned to read music. Most importantly, Kevin attended Slavonic Liturgy with his maternal grandmother, Mary Dzura every Sunday and followed along with his prayer book learning to read Church Slavonic. Thus began a devotion to the church that continues to this day.

Kevin cantored his first solo Liturgy on August 6, 1973, and received additional guidance on Holy Days with Lefty Lopata singing along for moral support. Steve Malitak from Holy Spirit, on Pittsburgh's North Side, cantored funerals and taught Kevin the funeral melodies in both English and Church Slavonic.

A few years later Joe Matvey completed the course at the Metropolitan Cantors Institute and joined Kevin as a cantor for St. John Chrysostom. Joe's son David would also learn to cantor for the parish. Kevin inherited the role of lead cantor from Frank Kostilnik. Kevin became cantor at Nativity of the Blessed Virgin Mary (Greenfield) when Cantor George Gavula became ill. Kevin continued in that role until the closing of Nativity of the Blessed Virgin Mary church. In 2014 when +Fr. Thomas Schaeffer was Administrator of St. John the Baptist (South Side) and cantor Joseph Ruglovsky moved away, Kevin assumed the duties of cantor there.

As a student at the University of Pittsburgh, Kevin sang with the University's Men's Glee Club, traveling with them to Europe in 1990 for the group's 100th Anniversary. He also sang with the Heinz Chapel Choir in 1989, traveling with them to California to perform. In 2019 Kevin retired from the Post-Gazette as a mailer, having started with the Pittsburgh Press in 1974. Kevin is also a life-long GCU Member.

In August 2022 Kevin announced his intention to retire in September 2023 as cantor and his wish to train a replacement. For one full year, Kevin trained two men to become cantors. Andrew Prizzi of St. John the Baptist and Eric Williams of St. John Chrysostom assumed the duties of cantor for their respective churches effective September 1. In retirement Kevin will continue to share his gift with the parish community, helping with Holy Days, funerals and an occasional Divine Liturgy, and most importantly offering encouragement and support to his successors. So, while "Thank You" may be somewhat insufficient, our gratitude for Kevin's commitment to St. John Chrysostom and St. John the Baptist Churches and his 50 years as cantor is truly heartfelt. Like all major events of the Province, the celebration began with a Divine Liturgy of Thanksgiving. As is customary on this occasion and before receiving the Holy Eucharist, Sister Christopher renewed her vows. In this, she was joined by the entire community.

In his homily, Archbishop William remarked on the many levels of service and the many different roles that Sister carried out in her 75 years of service. Speaking to the time when he was Bishop of Phoenix, he noted that faced

with the enormous task of managing the apartment complex at St. Stephen's, Sister worked hard to get everything organized, and in so doing engaged others in the parish to help.

Her purpose went beyond practicalities of the buildings, and extended to spiritual counseling when needed. Sister's ministry in the Eparchy of Phoenix for nearly thirty years actually began in 1991, assisting in organizational work in what

Sister Christopher spent her beginning years as a Basilian in the teaching ministry. Her abilities led to the assignment as Motherhouse Superior and then as Provincial Superior for two terms. In 1983, she was elected as General Superior, the highest position in the Order based in Rome. In this capacity, she touched the lives of many Sisters, particularly those still living under communism. Even at this date, she is fondly remembered for her courage in visiting those groups of Sisters during her tenure.

Because of health issues, Sister Christopher returned to the monastery at Mt. St. Macrina in 2018, assisting part time at the Religious Gift Shop or wherever needed. Presently, Sister Christopher is a resident at Mt. Macrina Manor where she previously offered her services as a volunteer.

At the festive dinner following the Liturgy, Provincial Sister Susan congratulated Sister Christopher and thanked her for her enthusiastic and faithful service. She then read a very special message from the Sisters in Romania who are celebrating their 75th Anniversary as a Province. Sister Christopher holds a special place in their hearts, since it was through her that the Basilian Sisters in Romania became a part of the Order. Truly, one can say that Sister Christopher has been blessed with many happy and spiritually fruitful years, and all of us are grateful to share in this blessing!

Sister Josetta Kriss

Patiently waiting for the Lord Jesus to call her home, Sister Josetta (Angela) Kriss quietly fell asleep in the Lord on Saturday morning, November 18, 2023 at Mt. Macrina Manor. She awoke from her life's journey to be welcomed to her new home in the Kingdom.

Sister Josetta was born in Canonsburg, PA, the daughter of the late Charles & Susan (Hoady) Kriss. She entered the community from St. Michael Byzantine Catholic Church in Canonsburg, PA on September 15, 1956 and made her Final Profession of Vows on August 26, 1962.
